PROPOSAL

Demolish a ca. 1932 house.

ARCHITECTURE

One-story rectangular-plan clipped cross-gabled frame bungalow with a partial-width clipped front-gabled independent porch on capped brick piers and short battered posts; single and paired 1:1 windows.

RESEARCH

The house was built in 1932 by Walter Bremond, a local businessman who dabbled in Austin real estate. The first known residents were Paul J. and Ila M. Gresham, who appear in the 1932-33 city directory. Gresham was born in Oklahoma and grew up in Lockhart, Texas, the step-son of an insurance agent. In 1930, according to the U.S. Census report, Gresham was unmarried and living in Lockhart in his parents' house. He was a book-keeper for a grocery store. He married between 1930 and 1932, and was working as an insurance agent in Austin when he and Ila bought this house. They only lived here a short time; by 1935, city directories reveal that the house was owned and occupied by Edgar F. Nauert. Nauert was the son of a tenant farmer in the Dessau area of Travis County, and while living in this house, worked as a lineman for the City Electric Department. Edgar and Marie Nauert lived here until the mid- to late-1940s. The house was then purchased by Scott and Gay McGinnis; McGinnis was a partner in a real estate firm in the Littlefield Building; they lived here from the late 1940s through the early 1950s. Beulah M. Shepherd is listed as the owner and occupant of the house through the rest of the 1950s. The house was then rented by at least two families in the 1960s, then purchased by Lena Hagman, the widow of a hardware salesman from Elgin and Taylor, Texas. Mrs. Hagman lived here until her death in 1983. Since that time, the house has been a rental property.


STAFF COMMENTS

The house is beyond the bounds of any City survey.

STAFF RECOMMENDATION

Although staff cannot justify this house for landmark designation due to its lack of historical significance, staff strongly urges the applicant to consider rehabilitation and addition, or at the least, relocation of the house over demolition.

BIOGRAPHICAL NOTES

Paul and Ila Gresham (ca. 1932 – ca. 1934)

The 1930 U.S. Census report shows Paul Gresham as the 23-year old son (step-son?) of Walter and Virginia Parker, who rented a house in Lockhart, Texas. Walter Parker was an insurance salesman; Paul, who was not yet married, was a book-keeper at a grocery store. He had been born in Oklahoma, and is believed to have died in 1969 in Oklahoma City.

Edgar and Marie Nauert (ca. 1934 – ca. 1947)

Edgar and Marie Nauert appear in the 1930 U.S. Census report living at 2307 Lafayette Avenue, a house they rented. They had two young children and a 22-year old female lodger from Minnesota. Both Edgar and Marie had been born in Texas. Edgar was then 25; Marie was then 23 years old. He is listed as a lineman for the City. The 1920 U.S. Census shows that Edgar was living with his parents in the Dessau area of northern Travis County. His father, C.F. was a tenant farmer; 15-year old Edgar had no occupation listed. The 1910 U.S. Census shows Edgar as a 5-year old on his parents' farm on the Manor-Jollyville Road in Travis County. Edgar Nauert died October 11, 1973 in Williamson County, Texas, but no obituary seems to have been printed in the Austin newspapers.

Lena Hagman (ca. 1971 – ca. 1983)

Around 1971, when Lena Hagman moved into this house, her husband, Carl Alex Hagman, had recently died (July, 1971). The 1930 U.S. Census shows Alex and Lena Hagman living in a rented house in Taylor, Texas with their son, Leonard, and daughter, Vera. Carl Hagman was a 46-year old Swedish-born hardware salesman. Lena Hagman was then 39 years old and had been born in Texas to Danish-born parents. She had no occupation listed. Daughter Vera was then 19 and worked as a saleslady in a dry goods store. Son Leonard was then 19 and worked in a tailor shop. They had a 40-year old lodger, who worked for an oil driller. The 1920 U.S. Census shows C. Alex and Lena Hagman living in Taylor, Texas, but Leonard is listed as Leonard Brown, her son; Vera is listed as Vera Hagman. Carl Hagman worked as a hardware salesman.

Lena Hagman

Lena Hagman, 93, of Austin, died Monday.

Formerly of Elgin, she had been a resident of Austin for the past 15 years. She was a member of the Memorial United Methodist Church.

Survivors include daughter Vera Hagman of Austin; son, Leonard Hagman, of Austin; four grandchildren, and four great-grandchildren.

Funeral services will be held at 2:00 PM Wednesday in the Colonial Chapel of Cook-Walden Funeral Home, with Reverend John Berkley and Reverend Bobbi K. Clouinger officiating. Interment will be in Taylor City Cemetery.
