PROPOSAL

Demolish a ca. 1948 house.

ARCHITECTURE

One-story, rectangular-plan, side gabled frame house with synthetic siding; partial-width flat-roofed over-door hood; metal-framed multi-light casement windows; stone wainscot across the front of the house.

RESEARCH

The house was built in 1948 by plumber T.P. Porter as an investment duplex. Tenants included a food condiments salesman, a car serviceman, and a widow.


STAFF COMMENTS

The house does not appear in any City survey.

STAFF RECOMMENDATION

Release the demolition permit. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.
