**TERMINATION OF RESTRICTIVE COVENANT**

**OWNER:** CSK Partners, LLC, an Arkansas limited liability company  
**ADDRESS:** 4320 Industrial Drive, Fort Smith, Arkansas 72916  
**CITY:** The City of Austin, a home-rule city, municipal corporation and political subdivision of the State of Texas, in Travis County, Texas.  
**CITY COUNCIL:** The City Council of the City of Austin.  
**CONSIDERATION:** Ten and No/100 Dollars (\$10.00) and other good and valuable consideration paid by the City of Austin to the Owner, the receipt and sufficiency of which is acknowledged.

WHEREAS, Travis 51, Ltd., a Limited Partnership, as owner of all that certain property described in Zoning Case No. C14-79-074, consisting of approximately 30.72 acres of land out of the Santiago Del Valle Grant, Travis County (the "Property"), as more particularly described in the restrictive covenant recorded in the Real Property Records of Travis County, Texas, in Volume 6605, Page 2160 (the "Restrictive Covenant"), imposed certain restrictions and covenants on the Property by the Restrictive Covenant of record; and,

WHEREAS, the Restrictive Covenant provided that the covenant could be modified, amended, or terminated by joint action of both a majority of the members of the City Council and the owner of the Property at the time of such modification, amendment or termination; and,

WHEREAS, CSK Partners, LLC, an Arkansas limited liability company, as sole and current owner (the "Owner") of the Property, now desires to terminate the Restrictive Covenant; and,

WHEREAS, the City Council and the Owner, agree the Restrictive Covenant should be terminated;

NOW, THEREFORE, for and in consideration of the premises and mutual promises, covenants, and agreements set forth in this covenant, the City of Austin and the Owner agree as follows:

1. The Restrictive Covenant is terminated by this termination. Each and every one of the terms, conditions, and provisions of the Restrictive Covenant, as set forth in the Restrictive Covenant, shall have no force or effect on and after the effective date of this termination.

The City Manager, or his designee, shall execute, on behalf of the City, this Termination of Restrictive Covenant for Zoning Case No. C14-79-074(RCT) (the "Termination of Restrictive Covenant") as authorized by the City Council of the City of Austin. This Termination of Restrictive Covenant shall be filed in the Official Public Records of Travis County, Texas, which will terminate the document of record in Volume 6605, Page 2160, Real Property Records, Travis County, Texas.






