Authorize award and execution of a 24-month requirements supply agreement with GENERAL TRAFFIC EQUIPMENT CORPORATION traffic signal heads for the Transportation Department in an amount not to exceed \$118,800 with three 12-month extension options in an amount not to exceed \$59,400 for each option, for a total contract amount not to exceed \$297,000.

Amount and Source of Funding

Funding in the amount of \$47,025 is available in the Fiscal Year 2011-2012 Operating Budget of the Transportation Department. Funding for the remaining 19 months of the original contract period and for the extension options is contingent upon available funding in future budgets.
