This contract is for the purchase, delivery, and installation of Bermuda turf-grass sod and sprigs for the Morris Williams Golf Course.

The City of Austin Parks and Recreation Department has begun renovation to the Morris Williams Golf Course. The renovation will utilize in-house Golf Division staff.
