- Monitor speakers should be limited to mic stand mounted personal monitors
- No subwoofers larger then 15" shall be used at this location for any event
- Appropriate musical styles and instrumentation for this location-no hard rock or heavy bass
- Availability of responsible pary to attend and monitor outdoor music events
- 70 decibel sound limit
- Limited to one larger event in parking lot per year

- No larger parking lot even sound amplification shall go beyond 7:00 p.m. on any night of the week
- Subject to 60 day review
