GENERAL DESCRIPTION OF SURROUNDING AREA

Lucy's Fried Chicken is off of South Congress and located among other small businesses and is across alley from property with residential use. There are residential neighborhoods to the east and west of the establishment. The restaurant intends to host live performers/ambient music that will be located on a small outdoor patio situated on the north/west portion of the property.

IMPACT ON RESIDENTIAL PROPERTIES

There has been neighborhood opposition to this sound permit. Sound equipment is located within 600 feet of residential use and zoning.

Regarding city code § 9-2-53 **DECISION ON APPLICATION:**

(C) The accountable official may NOT deny an initial permit for an outdoor music venue located within the footprint of a restaurant (general) use under Section 25-2-808 (Restaurants and Cocktail Lounges), but the accountable official may:

- (a) impose conditions on the permit, as provided in Subsection (B)(2) of this section; and
- (b) deny an application to renew the permit under Section 9-2-32 (Denial of Permit for Repeated Offenses)* based on repeated violation of applicable decibel limits.

MUSIC OFFICE RECOMMENDATIONS

The main speakers must be angled downward and are not to exceed 12 " woofers.

Monitor speakers should be limited to mic stand mounted personal monitors.

No subwoofers larger than 15" shall be used at this location for any event.

Appropriate musical styles and instrumentation for this location, no hard rock or heavy bass.

Availability of responsible party to attend and monitor outdoor music events

70 decibel sound limit.

Limited to one larger event in parking lot per year (requires TUP).

No larger parking lot event sound amplification shall go beyond 7:00 pm on any night of the week.

Cut off times are restricted to 8:00 pm Sunday-Thursday and 10:00 pm Friday and Saturday.

70 decibel sound limit. Approval subject to 60 day review.
