#### Susan-

I am just walking in the door between appointment and getting this. I also see now there is a great deal of new information scanned into system I have barely had a chance to glance at.

I am concerned that I see some misinformation and will need time to respond and am tied up this afternoon. There has been a lack of accuracy and opposing and inconsistent direction and opinions given to me by different people at the city regarding deadlines, forms and this entire process. Even this hearing was scheduled without my knowledge despite the fact that I had yet to have my 25-1-186 meeting with the director to attempt to resolve matters and having been told that nothing would be scheduled prior to that or without notice. I only learned by accident of this having been scheduled seeing it in Amanda during a Holiday weekend with the offices closed for several days. It was scheduled a week earlier without my knowledge. How could this be?

I was preparing for the meeting with Greg that had been scheduled for the next week to discuss those issues in the appeal and so I have a fair level of fact.

I understood this was the due process before any steps to BOA would take place. I wanted to see what if any concerns might be resolved and asked a reasonable 2 weeks time once those meetings had occurred to complete any BOA applications or other revisions. Facts ascertained and outcome of that meeting would affect what issues remain and how any subsequent appeal form would be filled out. I needed reasonable time to properly prepare and complete applications beyond this as information could change.

I had received no communication from city staff for 3 1/2 weeks after submitting my initial appeal to PDR and then with no response to the concerns or points I made in my appeal.

I immediately replied back as there was no mention of the meeting or process as I understood would take place. It had been represented to me that I would first get a response from them and have an opportunity to meet to discuss and attempt to resolve those concerns formally with PDR before any moves to BOA would take place and my future appeal rights would be honored.

I requested the code mandated meeting and later spoke with Greg Guernsey late on May 18. We explored times and coordinated schedules for the 25-1-186 meeting with an agreement to be in touch to confirm a date by the next Tuesday. He deferred any additional requirements for BOA at this time. It had been weeks since I heard from them and I wanted the opportunity for the due process as represented. There are other obligations I have to work around and I did not want to be in a disadvantaged position without enough time to properly prepare.

We confirmed the meeting as agreed for the next week. However a few days later after hours on Friday of a holiday weekend, I find another email from him with a conflicting directive regarding deadlines again, and with no ability to reach him to discuss matters with the office closed for 3 days. This did not align with our previous conversation, the meetings had not yet occurred. He also wanted to schedule a meeting with the Prairies and myself to see what might be resolved. I was agreeable and thought a good idea, but first wanted to have my meeting with him to see what could be resolved and time to digest any new information so suggested he stagger these a couple days apart. I replied right away but this all transpired after hours Friday of a holiday weekend, so it was several days before any of this could be addressed. There was no mention of any hearing.

Susan, I do not have time to even complete this note to you as I see the time and have another apportionment and want to get this to you before you leave. The deadlines and information keep changing. I have other information I would like to submit and would like to continue with the above inforantion surrounding the process. I continue to find myself in a position of scrambling with roadblocks and things changing at the last minute. I have evidence to support everything stated.

## Right now, I would like to know:

- what is the deadline to get anything into the BOARD advance package. Will you include anything you get tonight or before tomorrow morning? What time?
- Is there another deadline for Monday for late backup? What time?
- I would like the opportunity to include some additional information in advance.
- · what is the procedure and for filing a postponement?
- · how much notice do you need? IS there a deadline?
- will the details for your request be submitted to the board or is it just an announcement?
- must you be present at the BOARD for this?
- Is there a minimum amount of time or must you be date specific?

Can you please reply with answers to the above questions before you leave today?

I need your immediate response so I will know how to proceed.
