1. **CALL TO ORDER:** Commissioner Hernandez, acting as Chair, called the meeting to order at 6:35 p.m.

The gist of his thoughts was that Secure Communities was worthwhile and could be improved if the process was amended to prioritize deportation of those who are "really" a threat to the community.
