- §13-2-34(G) Insurance Required
 - The formula should be clear regarding insurance coverage.
- §13-2-277(B) Compliance Required
 - Revise last sentence of Section B to read: Fare rates may be fixed or for tips only, and negotiated with the passenger prior to service being rendered.
