PROPOSED DEVELOPMENT:

The applicant is requesting a fourth extension of 10 years to a previously approved site plan.

The project is for the continued completion of the construction of a private secondary educational facility. A majority of the site plan has been developed in accordance with the approved site plan. The site is located within the City's 2-mile ETJ. The extension would allow the owner to complete the construction of the school campus, by raising additional funds.

The remaining improvements include a new academic wing, a basketball gymnasium, construction of a fire access and other associated buildings and parking for the school facility.

There is an on-site detention pond which was sized to accommodate the total build out of the school campus.

SUMMARY STAFF RECOMMENDATION:

Staff recommends approval of the 10 year extension based on LDC Section 25-5-62(C)(1)(c) – the applicant constructed at least one structure shown on the original site plan that is suitable for permanent occupancy.

The 10 year extension will extend the permit from May 19, 2012 to May 19, 2022. Additional time could be granted by the Zoning and Platting Commission because the site plan received grandfathering protection; therefore Project Duration does not apply to this project. If the project were submitted today, the owner would be allowed to construct the same project.

This is the fourth extension request for this project. Since the last extension was approved 6 years ago, numerous improvements have been completed, such as the baseball field improvements, campus center building, remodeling of the football and baseball concession stands, football press box, reception area, track and high jump pit. The site plan complies with all requirements of the Land Development Code in effect when the site plan was originally approved.

COMPARISON OF THE APPROVED PLAN WITH CURRENT REGULATIONS:

SOS WATERSHED ORDINANCE: This project is grandfathered under an old waterway development permit. Current SOS regulations limits the impervious cover to 20% and call for a re-irrigation of the water quality pond. The plan has a detention pond with a vegetative downstream buffer.

SUMMARY COMMENTS ON SITE PLAN:

The site is outside the City's Full Purpose jurisdiction, but within the 2 mile ETJ. Zoning is not required. A majority of the school campus has been constructed, and numerous improvements have been made since the last extension was granted in 2006. An entire academic wing remains to be constructed, as well as a gymnasium. Since this is a private school, it takes fundraising and pledge campaigns to raise the funds for the remaining improvements which can take several years.

ENVIRONMENTAL:

This site is located in the Barton Creek Zone, but not within the recharge zone.

TRANSPORTATION:

There are two proposed driveway access points onto Barton Creek Boulevard. Travis County has previously signed off on these driveways.

COMPATIBILITY

The site and surrounding tracts are within the ETJ, therefore compatibility standards would not apply.

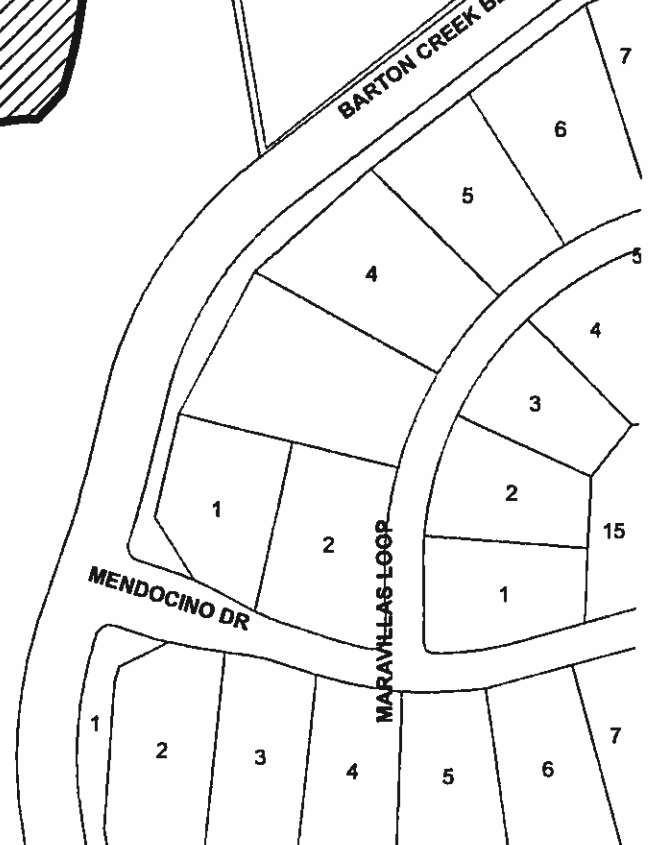
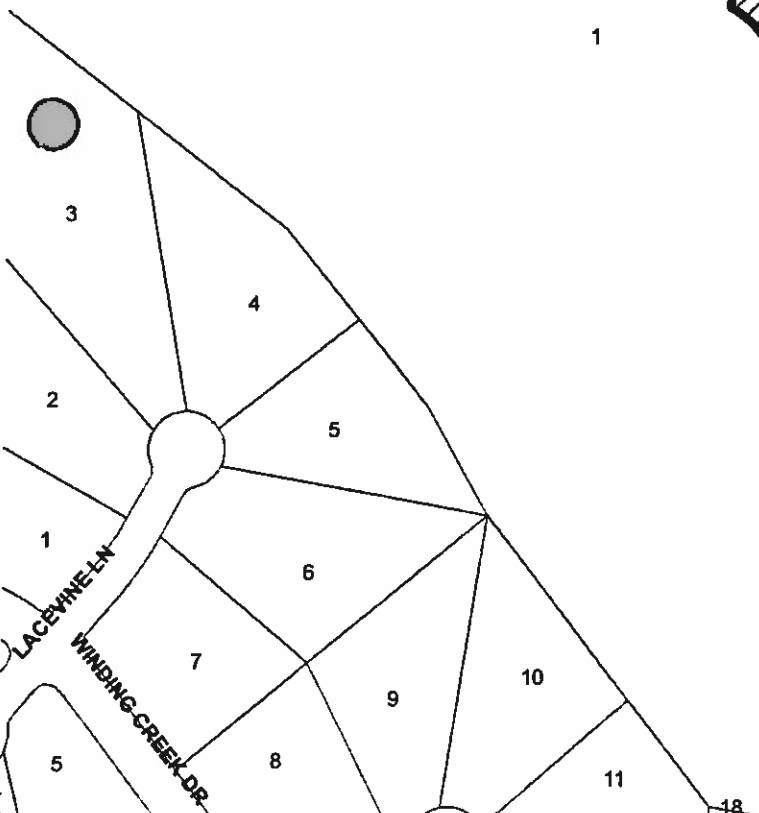

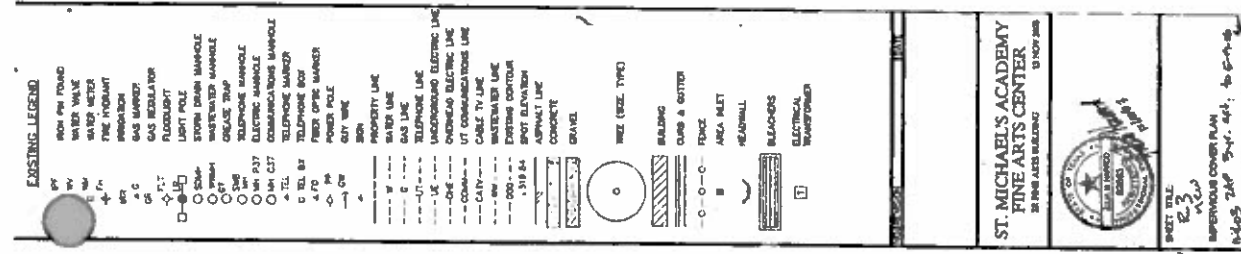

Dear Review Team:

By this letter, Land Strategies, Inc. respectfully requests a ten-year extension to the existing Site Plan, SP-99-0107D, in order to continue the proposed building expansion and improvements on the school site. The primary anticipated proposed expansion and improvements include the following elements: Construction of a new Academic Wing; Construction of a new Basketball Gymnasium; and Construction of Fire Access, as per Fire Department requirements.

On June 6, 2006, the Zoning & Platting Commission approved a six-year site plan extension, revising the expiration date of the site plan to May 19, 2012. Since that time, campus expansion and improvements have continued on the St. Michael's Catholic Academy property, as shown on the attached Exhibits A and B. Approximately \$7.4 million in improvements have been made to the campus over the last six years. In 2007, a new Campus Center was constructed. In 2008, a Site Plan Correction was approved for the addition of a running track around the football field. Additionally in 2008, a separate Site Plan Correction was approved for changes to the courtyard paving pattern and layout, the replacement of an existing dirt road by a paved road (based on Travis County fire access requirements), and updates to location and configuration of a water line. Finally, in 2011, a Site Plan Correction was approved, allowing the relocation and or removal of portable buildings on the overall St. Michael's property. Please see Exhibit C for these referenced changes. Over the last several years, we have worked with the City of Austin on these campus improvement plans, and have added Sheet 28 of 29, which reflects the future building plans and associated impervious cover requirements and improvements.

We believe that these continued expansion plans and improvements show good faith on the part of the Academy to continue to improve the campus. Therefore, Land Strategies, Inc. requests this ten-year extension in order to prepare possible future site plan revisions and/or corrections as the school and its needs continue to grow and expand.

Dear Nikki:

This letter is provided to address your comment SP3, for the St. Michael's Catholic Academy site plan extension request, located at 3000 Barton Creek Boulevard, in the ETJ of Austin, Travis County, Texas. That comment reads:

"Provide a letter and documentation from the owner justifying how his or her actions following the site plan approval and release demonstrate a "good faith effort" as required by 25-5-62(C)(1)(b)."

As you can see on the attached exhibits, we have been diligently working on our campus expansion since the original site plan was approved in 1984. We received a site plan extension in 2006 (to expire in May 2012), for which we provided the attached Campus Enhancement Plan (dated February 20, 2006) as justification for the site plan extension request. As you can see on that enhancement plan exhibit, we had planned many improvements and construction projects between 2006 and 2012, many of which have been completed. The additional exhibits reflect the improvements/construction projects that have been completed since the 2006 site plan extension approval, totaling approximately \$7.4M. We will, however, require additional time to complete our overall campus expansion/construction plan (as detailed on the color exhibit), as, being a private school, it takes a significant amount of time to raise the funds necessary to pay for these improvements.

Based on past campus expansion improvements, as well as the future proposed improvements designated on Sheet 28 of the overall site plan set, I believe our actions provide a "good faith effort" to complete the campus expansion/construction as approved with the original site plan.
