- 3. Authorize award and execution of a contract with SOLAR COMMUNITY or one of the other qualified offerors to RFP No. TVN0023, for the installation of seven solar photovoltaic systems at the Palmer Event Center in an estimated amount not to exceed \$500,114.
- 4. Approve the issuance of a Letter of Intent for a Performance Based Incentive to HOLT CAT, for the generation of solar energy at their facility located at 9601 S. Interstate 35, Austin, TX, for an estimated \$44,670 per year with the total amount not to exceed \$446,700 over the 10-year agreement.
- 5. Approve issuance of a rebate to Dell Computers, Inc. for the installation of energy efficient equipment in an amount not to exceed \$127,158.
- 6. Approve issuance of a rebate to The University of Texas for the installation of energy efficient equipment in an amount not to exceed \$200,000.
