B. RESIDENTIAL DESIGN AND COMPATIBILITY STANDARDS

**B-1 2012-017858R Ryan Vinson
1809 Schulle Avenue**

The applicant has requested a modification to allow a F.A.R. increase from the maximum development permitted in Chapter 25-2 of the Land Development Code, Section 2.1 Subchapter F: Residential Design and Compatibility Standards from the allowable 40% (2730 sq ft) to 46.8 % (3188 sq ft) for new construction of a 2sty single family residence in a SF3-NP zoning district.
