<u>SUMMARY STAFF RECOMMENDATION</u>: Staff does NOT recommend a proposed zoning change from single family residence – Neighborhood Plan (SF-3-NP) to single family residence – Historic Landmark – Neighborhood Plan (SF-3-H-NP), and instead recommends completion of a City of Austin Documentation Package consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history of the house for archiving at the Austin History Center.

QUALIFICATIONS FOR LANDMARK DESIGNATION:

The ca. 1917 house is a transitional cottage, a relatively common house type in Austin, and is associated with the Thomas Odell family and the Richard Preece family. Thomas and Beulah Odell lived here from approximately 1917 to around 1919 – he was a helper in a new and second-hand furniture store. Richard and Mary Preece purchased the house around 1922, and members of their family lived here until very recently. Richard Preece was a janitor at the University of Texas from the time he and Mary moved into this house until his retirement in 1950. Staff does not believe that the house meets the criteria for individual landmark designation for architecture and historical significance.

BASIS FOR RECOMMENDATION:

Architecture:

One-story rectangular-plan hipped-roof frame house with board-and-batten siding; partial-width inset porch; single and paired 1:1 fenestration; corrugated metal roof. There is a one-story rectangular-plan shed-roofed frame addition to the rear of the house with louvered windows overlooking the back yard. The house is considered to be a transitional-style house, blending elements of popular Victorian-era design with the incipient bungalow form.

Historical Associations:\

The house appears to have been built around 1917, as the address first appears in the 1918 city directory, showing Thomas L. and Beulah Odell as the residents. Thomas L. Odell was working as a helper in a new and second-hand furniture store prior to moving into this house; the family lived here until around 1919 – the 1920 U.S. Census shows the Odell family living in rural Bell County, Texas, where Thomas was farming. The house is listed as vacant in the 1920 U.S. Census report, but by 1922, Richard L. Preece had purchased the property. Members of the Preece family have owned and occupied the house since around 1921 until very recently. Richard L. Preece was a janitor at the University of Texas, a position he held until his retirement around 1950. He and his wife Mary lived here until they passed away – Mary Preece died in 1950; Richard Preece died in 1959. The house was then occupied by their daughter, Lohma, who was married to Joe C. Miller, who died in 1966. Lohma Miller continued to live here until her death in 1989; the house was then owned and occupied by Lohma Miller's daughter, Lohma Ritcheson, who died in 2002.





BIOGRAPHICAL NOTES


THOMAS L. and BEULAH ODELL (ca. 1917 – ca. 1919)

T.L. and Beulah Odell appear in the 1920 U.S. Census for Bell County, Texas, where they lived on a farm. T.L. Odell was then 42, had been born in Texas, and is listed as a farmer on a general farm. Beulah Odell was then 38, had been born in Texas and is listed as a housekeeper at home. They had two sons, Leslie, 17, and J.D., 15, as well as two daughters, Nadine, 11, and Estelle, 8. Leslie was an aviator; the rest of the children were listed as farm laborers. The 1940 U.S. Census report shows Tom and Beulah Odell living on a farm in Bell County.

RICHARD L. and MARY PREECE (ca. 1921 – ca. 1959)

Richard and Mary Preece appear in the 1920 U.S. Census living at 58 Chicon Street, a house they rented, with their daughter, Lohma. Richard Preece was then 42, had been born in Texas, and was employed as a janitor at the University of Texas. Mary Preece was then 30, had been born in Texas, and had no occupation listed. Lohma Preece was almost 2 years old.

The 1930 U.S. Census shows the family living at 2300 Garden Street (although this is probably Holly Street). They owned the house, which was worth \$350. Richard Preece is listed as a janitor at the University of Texas.



Richard Preece's World War I draft registration card shows that he was living at 58 Chicon Street with his wife Mary, had been born in 1877, and worked as a laborer on sewer lines for the City of Austin. The draft registration card also notes that he had a fractured skull.

RICHARD L. PREECE

Richard Lincoln Procee, 72, of J 2200 Holly Street, died at his residence Saturday night. He was a retired employe of the University of Texas and had been a resident of Austin since 1912. Prece was a member of the Pentecostal F Church, the Modern Woodman of the World and the Royal Neighbors.

Survivors include one daughter. Mrs. Loma Bell Mueller of Aus-Austin, two brothers, William Preece, F. and Ellis Preece both of Volente: L. and two grandchildren. Lohma Jo. S. Mueller and Charlotte Gayle Mueller both of Austin.

Funeral services will be held A Monday at 2 p.m. at the Hyltin-is Manor Funeral Home with the deriver. Robert L. Weathers officiating Burial will be in the Bag. A dad Cemetery at Leander.
