

PUBLIC SAFETY COMMISSION MINUTES

REGULAR MEETING Tuesday, September 4, 2012

The Public Safety Commission convened in a regular meeting on Tuesday, September 4, 2012 at City Hall, 301 West 2nd Street in Austin, Texas.

1. Approval of Minutes

a. The minutes for the regular meeting on 08/06/2012 were approved on Commissioner Holt's motion, Commissioner Rossmo's second on a 5-0 vote with Commissioner Ko not present.

2. Citizen Communications

- a. Sylvia Benini, Austin Citizen, spoke regarding the Austin Police Department's handling of Occupy Austin issues, and recent report of APD's involvement in Harris County investigation.
- b. Antonio Buehler, Austin Citizen, spoke regarding his recent arrests, and APD's involvement in the Occupy movement report coming from Harris County.
- c. Claire Hirschkind, Austin Citizen, spoke regarding her arrest at City Hall during Occupy Austin on February 3, 2012.

 a. EMS Paramedic Vacancies – presented by A/TCEMS Chief of Staff James Shamard and A/TCEMS Assistant Director of Finance John Ralston.

Discussion was held regarding the discrepancies in the number of EMS Paramedic vacancies, as reported by various media and city agencies. Chief of Staff Shamard advised

that the current Paramedic vacancy rate is 49 vacancies, 12 of which are new positions at the new Mueller station, which is still under construction. Backup material archived.

b. City Administrative Obligations to the Public Safety Commission – comments presented by Chairman Michael Lauderdale

NOTE: This item was initially skipped, and these comments ultimately came at the conclusion of discussion of item 3.c.

Chairman Lauderdale expressed displeasure with finding out about critical public safety issues from the local media rather than it coming from the affected departments. Chairman Lauderdale charged each of the Chiefs of Staff with providing that information in a timely manner to the commission.

c. Wild Fire Risk – presented by AFD Chief of Staff Harry Evans, Austin Fire Fighters Association President Bob Nicks, and AFD Chief Engineer Carl Wren. Discussion was held regarding the fact that despite the acknowledged Wild Fire Risk, no money has been budgeted in the proposed City of Austin Budget for a Wildland Fire Division. A report was presented to the commission by Chief of Staff Evans. Backup material archived.

Chairman Lauderdale advised that he will have further discussions with City Council to once more push forward the idea of funding a Wildland Fire Division.

- e. Neighborhood Enforcement Issues presented by APD Chief of Staff David Carter, Assistant Chiefs Patrick Ockletree and Raul Munguia, Assistant District Attorney Dayna Blazey and Assistant City Attorney David Douglas.
 - i. 12th Street and Chicon Area presented by Assistant Chief Ockletree Discussion was held regarding the Sit and Lie ordinance and the feeling that it would be ineffective in this area, and other initiatives that are currently underway that should prove more productive.
 - ii. Downtown Area presented by Assistant Chief Munguia Discussion was held regarding the effectiveness of the Sit and Lie ordinance in the downtown area. Chief Carter advised that a report will be forthcoming that will address the effectiveness of the ordinance.
 - iii. Travis County District Attorney representative presented by ADA Dayna Blazey

ADA Blazey discussed enhanced prosecution in the downtown business area, as well as prosecution in general citywide.
