C. REVIEW OF PERMITS IN NATIONAL REGISTER HISTORIC DISTRICTS

1. NRD-2012-0097

2301 Woodlawn Boulevard (Old West Austin)

Proposal: Construct two-story additions on front and side of existing house, cover exterior masonry with stucco, and add second story balcony with a decorative railing.

Applicant: Catherine and Dennet Wenske, Owners

City Staff: Alyson McGee, Historic Preservation Office, 974-7801

Staff Recommendation: Release the building permit with the recommendation that the applicant consider revisions to the design to maintain the property's contributing status. If the applicant pursues the proposed design, require submittal of a City of Austin documentation package.

No speakers in support. Dennet Wenske signed in support but did not speak.

No speakers in opposition. The public hearing was closed on Commissioner Rosato's motion, Commissioner Galindo second on a 5-0 vote.

2. NRD-2012-0100

1806 W. 11th Street (Clarksville)

Proposal: Relocate existing house on the lot and construct a one-story rear/side addition, and construct a new guest house at rear of lot.

Applicant: Carolina Cantu, Clayton & Little Architects

City Staff: Alyson McGee, Historic Preservation Office, 974-7801

Staff Recommendation: Release the permit per the proposed design.

No speakers in support or in opposition. The public hearing was closed on Commissioner Rosato's motion, Commissioner Galindo second on a 5-0 vote.

COMMENTS: Accept staff's recommendation with no additional comments.

3. NRD-2012-0093

416 E. 6th Street (Sixth Street)

Proposal: Extend the rooftop deck and construct a new metal guardrail at the front parapet.

Applicant: Afshin Mohammedzadeh

City Staff: Steve Sadowsky, Historic Preservation Office, 974-6454

Staff Recommendation: Approve as proposed.

Steve Simon and Afshin Mohammedzadeh signed in support but did not speak. Steve Simon addressed the Commission to answer questions on the project but there was no public hearing at this time.

COMMENTS: Commissioner Myers commented on her concern that many 6th Street buildings now unnecessarily have rooftop decks. Commissioner Limbacher suggested that a better option for screening the air conditioning unit from the parapet would be to build an operable screen around the unit only. An extended roof top deck and railing would not be necessary. Commissioner Limbacher would like clarification on what the Downtown Plan says about roof top decks and a requirement of a 15-foot setback to any rooftop additions.

MOTION: Postpone to September 24, 2012 to allow time for clarification with City departmental staff on Commissioner Myers' motion, Commissioner Wolfenden –Guidry's second on a 5-0 vote.

613 Congress Avenue (Congress Avenue)

Proposal: Signage for 7-11

Applicant: Tommy Bell, Barnett Signs

Staff Recommendation: Approve as proposed.
