## **BRIEF EXPLANATION OF PROPOSED RULE**

Austin City Code Chapter 6-4-11(E) *General Regulations* requires all new commercial developments or redevelopments located within 250 feet of a reclaimed water distribution line to utilize permitted connection to reclaimed water for irrigation, cooling, and other significant non-potable water uses. This rule provides for the adoption of rules that establish the applicability of Subsection 6-4-11(E) and a date of compulsory implementation.

## **TEXT OF PROPOSED RULE**

Rules adopted pursuant to Subsection Chapter 6-4-11(E) shall at a minimum establish the applicability of this section and a date of compulsory implementation.

# AUTHORITY FOR ADOPTION OF PROPOSED RULE

The authority and procedure for adoption of a rule to assist in the implementation, administration, or enforcement of a provision of the City Code is provided in Chapter 1-2 of the City Code. The authority to regulate the water use is established in Texas Local Government Code Section 552.001 and Title 6 of Austin City Code.
