2. CITIZENS COMMUNICATION: GENERAL

Taxi Cab operator Joesph Iley spoke in reference to a gas powered golf cart located on Enfield Dr. Joseph questioned the City's involvement in enforcing the perimeters in which the golf carts will operate, as well as keeping illegal carts off the streets. Gordon Derr, Assistant Director with Austin Transportation advised the citizen that the issue would be addressed by Carlton Thomas, Transportation Regulatory Supervisor with Austin Transportation during the meeting.

Pedicab operator, Stephen Merritt requested to address the Commission in advance regarding agenda item 4C, Pedicab Moratorium, due to a scheduled pedicab appointment. Chair Lanier approved Mr. Merritt's request. Stephen spoke in regards to ghost pedicabs (permitted pedicabs that are non-existent). He is questioning if the issue was addressed under the Pedicab Moratorium. Carlton Thomas, Transportation Regulatory Supervisor with Austin Transportation addressed the issue raised by the citizen stating that all pedicabs will have to be shipped or in the owner's possession by December 31, 2012, or the compan's cap will be lowered.

Howard Lazarus, Director with the Public Works Department, and Michael Curtis, Division Manager with the Public Works Department, provided a presentation outlining what Neighborhood Connectivity does as a division, recently completed projects, and future projects that Neighborhood Connectivity will undertake. B. Valet Ordinance Changes – Briefing and Possible Action

Jason Redfern, Right-of-Way Manager with the Austin Transportation Department, provided a presentation regarding an assessment of Valet services, and an update on the Valet Ordinance Changes and proposed fee schedule. UTC approved staff recommendations to implement a revised fee schedule for valet operations at the November 1, 2012 Council. Two citizens addressed the commission in opposition of the changes.

On Chair Lanier motion, Commissioner Schaubert second, with Commissioners Holbrook-White and Truxillo absent, on a 5/0/0/2 vote, the UTC voted in support of staff's recommendation to implement a revised fee schedule for valet operations.

C. Pedicab Moratorium - Briefing and Possible Action

UTC recommended that the Moratorium end date be changed to November 30, 2013 to reflect their objection to a permanent cap for Pedicabs. Three citizens addressed the Commission.

On Commissioner MacKinnon motion, Commissioner Schaubert second, with Commissioners Holbrook-White and Truxillo absent on a 5/0/0/2 vote, the UTC voted in support of the item with a revision to the date November 30, 2013.
