## Parks & Recreation Board

### The Board/Commission mission statement is:

The purpose of the board is to advise the city council and the city manager regarding:

- 1. the acquisition, development, improvement, equipment and maintenance of city parks and public playgrounds;
- 2. the future development of city parks, playgrounds, and recreational facilities, and the purchase of additional land for those purposes; and
- 3. improvement in the maintenance, operation, and general welfare of the city's parks, playgrounds, and recreational facilities and their use by the public.

The board shall outline a general plan of development for new parks and playgrounds, including landscaping, roads, trails, buildings and equipment. The board shall submit the plan to the Planning Commission and the city manager for detail development, and the city manager shall then submit the plan to the city council for approval.

The board shall promote close cooperation between the City and all private citizens, institutions. And agencies interested in or conducting recreational activities, so that all recreational resources within the City may be coordinated to secure the greatest public welfare.

  - 3) BSMP Barton Springs and Zilker Park Master Plan joint working group of the Environmental and Parks Boards
  - 4) New: Parkland Dedication Fund work group, to include Parks and Legal
  - 5) New: Work group to discover natural play settings in a playground to set a standard of including same into every park playground
- B. Finalize work of the Cemetery Work Group of the Board tasked with:
  - 1) Improving working relationships between Parks staff, citizens, the cemetery contractor
