ORDINANCE NO. _____

1 AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE
2 PROPERTY LOCATED AT 1814 LIGHTSEY ROAD AND 2905 DEL CURTO
3 ROAD FROM FAMILY RESIDENCE (SF-3) DISTRICT TO TOWNHOUSE &
4 CONDOMINIUM RESIDENCE-CONDITIONAL OVERLAY (SF-6-CO)
5 COMBINING DISTRICT.
6

7 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:
8

9 **PART 1.** The zoning map established by Section 25-2-191 of the City Code is amended to
10 change the base district from family residence (SF-3) district to townhouse &
11 condominium residence-conditional overlay (SF-6-CO) combining district on the property
12 described in Zoning Case No. C14-2012-0032, on file at the Planning and Development
13 Review Department, as follows:
14

15 Tract One: A 1.33 acre tract of land, more or less, out of the Block 9, Theodore
16 Low Heights Subdivision, the tract of land being more particularly described by
17 metes and bounds in Exhibit "A" incorporated into this ordinance;
18

19 Tract Two: A 1.81 acre tract of land, more or less, out of Block 9, Theodore Low
20 Heights Subdivision, the tract of land being more particularly described by metes
21 and bounds in Exhibit "B" incorporated into this ordinance; and,
22

23 Tract Three: A 1.53 acre tract of land, more or less, out of Block 9, Theodore Low
24 Heights Subdivision, the tract of land being more particularly described by metes
25 and bounds in Exhibit "C" incorporated into this ordinance (all tracts collectively
26 referred to as the "Property");
27

28 locally known as 1814 Lightsey Road and 2905 Del Curto Road in the City of Austin,
29 Travis County, Texas, and generally identified in the map attached as Exhibit "D".
30

31 **PART 2.** The Property within the boundaries of the conditional overlay combining district
32 established by this ordinance is subject to the following conditions:
33

34 A. A site plan or building permit for the Property may not be approved, released,
35 or issued, if the completed development or uses of the Property, considered
36 cumulatively with all existing or previously authorized development and uses,
37 generate traffic that exceeds 232 trips per day.

2 B. Vehicular access from the Property to Lightsey Road is prohibited. All
3 vehicular access to the Property shall be from other adjacent public streets or
4 through other adjacent property.
5
6 C. Driveway construction for access to Del Curto Road may not exceed one
7 driveway cut.
8
9 D. Development of the Property may not exceed 36 dwelling units.
10
11 E. Development of the Property may not exceed an impervious coverage of 47.4
12 percent.
13
14 F. The following uses are prohibited uses of the Property:

15
16 Duplex residential
17 Single-family attached residential
18

19 Except as specifically restricted under this ordinance, the Property may be developed and
20 used in accordance with the regulations established for the townhouse & condominium
21 residence (SF-6) base district and other applicable requirements of the City Code.

Humphries et Ux, by deed recorded in Volume 1292 Page 94 of the Deed Records of Travis County, Texas;

THENCE crossing said Block 9 with the west line of said Russell and Masterson tract, N 30 deg. 35' 49" E 5.00 ft. to a ½ inch iron rod set with plastic cap marked "Holt Carson, Inc." at the southeast corner of that certain tract conveyed to Veda Russell by deed recorded in Document No. 2000026029 of the Official Public Records of Travis County, Texas, and being the most northerly east corner of said City of Austin tract, and being the southeast corner and PLACE OF BEGINNING of the herein described tract of land;

THENCE with the current north right-of-way line of Lightsey Road, being the north line of said City of Austin tract, N 60 deg. 00' 00" W 92.04 ft. to a 60 D nail set in an asphalt drive at a point of curvature;

THENCE continuing with the northerly and easterly lines of said City of Austin tract, the following two courses:

1) 164.00 ft. along the arc of a curve to the right, having a radius of 104.00 ft. and chord bearing N 14 deg. 45' 00" W 147.53 ft., to a ½ inch iron rod set with plastic cap marked "Holt Carson, Inc. at a point of tangency in the east right-of-way line of Del Curto Road;

2) with the east right-of-way line of Del Curto Road, N 30 deg. 35' 49" E 201.75 ft. to a ½ inch iron rod set in the south line of that certain tract conveyed to the Ferguson Family Limited Partnership by deed recorded in Document No. 2003197598 of the Official Public Records of Travis County, Texas, and being at the most easterly north corner of said City of Austin tract, and being the northwest corner of said Veda Russell tract and being at the northwest corner of this tract, and from which a ½ inch iron pipe found at the northwest corner of said Block 9 bears N 60 deg. 00' 00" W 5.00 ft. and N 30 deg. 35' 49" E 145.00 ft.;

THENCE leaving the east right-of-way line of Del Curto Road and continuing across the interior of said Block 9 with the north line of said Ora Claire Russell tract, S 60 deg. 00' 00" E 197.00 ft. to a ½ inch iron rod set with plastic cap marked "Holt Carson, Inc" at the northeast corner of said Veda Russell tract, and being the northwest corner of said Russell and Masterson tract, and being the northeast corner of this tract;

THENCE with the common line of said Veda Russell tract and said Russell and Masterson tract, S 30 deg. 35' 49" W 306.53 ft. to the Place of Beginning, containing 1.331 Acres of land.






