Additional Backup Information	

The City (COA) has received several requests from local residents in the Whispering Oaks Neighborhood in South Austin to mitigate frequent flooding problems during heavy rain events. The Williamson Creek Blarwood Storm Drain project area is bounded by Campden Drive on the south, Baxter Drive on the north, Aldford Drive on the east and Blarwood on the west. The existing storm drain system in the project area was constructed in conjunction with the single family houses circa 1970. Development of the area occurred prior to the publication of the first COA Drainage Criteria Manual in 1977, therefore the area was designed under different drainage criteria. Numerous flood complaints have been registered in Watershed Protection Department's database.

This project alleviates the flooding of streets, houses and yards through an upgraded storm drainage system that includes the construction of 11,000 linear feet of upgraded storm drain pipe and numerous new storm drain inlets throughout the neighborhood. Residents have formally requested service from the City to address four locations of reported street flooding, seven locations of reported house flooding and sixteen additional locations of reported yard flooding.

Work consists of approximately 11,000 linear feet of storm drain improvements including curb inlets, junction boxes, reinforced concrete boxes, reinforced concrete pipes, a new outfall into Cherry Creek and repair of existing culverts, replacement of approximately 1,200 linear feet of water and 100 linear feet of wastewater lines and services, 35,000 square yards of street reconstruction and pavement replacement, curb, and gutter replacement.

This change order will add replacement of approximately 1,380 linear feet of 8-inch asbestos water line in Carlow Drive between Blarwood Drive and Baxter Drive and approximately 1,540 linear feet of 8-inch asbestos water line in Berkett Drive between Blarwood Drive and Baxter Drive. This change order also includes an extension of the mill and overlay improvements for these streets beyond the current limits of the project. This additional waterline replacement work will eliminate the need to return to the neighborhood at a later date.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right-of-way, a 10% contingency in funding has been included to allow for the expeditious processing of any change orders.

This project is located within zip code 78745 and is managed by the Public Works Department.
