AN ORDINANCE REPEALING ORDINANCE NO. 20130117-030 AND AMENDING ORDINANCE NO. 20121018-083 TO CORRECT THE LEGAL DESCRIPTION FOR THE PROPERTY DESCRIBED IN ZONING CASE NO. C14-2012-0064.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The legal description for the property described in Part 1 of Ordinance No. 20121018-083 is amended as follows:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from single family residence standard lot-neighborhood plan (SF-2-NP) combining district to townhouse & condominium residence-neighborhood plan (SF-6-NP) combining district on the property described in Zoning Case No. C14-2012-0064, on file at the Planning and Development Review Department, as follows:

A 1.1529 acre tract of land, more or less, out of the James O. Rice Survey No. 31, Abstract no. 675 the tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance (the "Property"),

locally known as 10652 Dessau Road, in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "B".

In all other respects the terms and conditions of Ordinance No. 20121018-083 remain in effect.
