Provide recommendation on the appeal of requirements under City Code Chapter 14-8-3 (B) 3 for the issuance of a street event permit for the Art City Austin to be held on Saturday, April 13, 2013 and Sunday, April 14, 2013. The director may not issue a closure permit for the following events without Council approval: (3) except as provided in Section 14-8-15, a right-of-way event if 20 percent or more of the affected persons on any block to be closed or a neighborhood association objects to the closure in writing on a form prescribe by the director;

Recommendations by Austin Transportation Department to the Urban Transportation Commission:

Under City Code Section 14-8-3 (*Restrictions on Issuance of Closure Permit*)(B) the Director may not issue a closure permit without Council approval for a right-of-way event if 20 percent or more of the affected persons on any clock to be closed or a neighborhood association objects to the closure.
