The Polygon 337 Project is a component of the Austin Water Utility (AWU) Renewing Austin Program (Program). This Program has been developed to rehabilitate the City of Austin's aging water infrastructure. The Program will replace 15 miles of water pipe per year.

The entire project is north of the UT campus within the boundaries of Dean Keeton Street to the south, Red River Street to the east, Harris Avenue to the north and Speedway to the west. The water rehabilitation consists of replacing approximately 12,326 linear feet of 6 –16 inch diameter water pipe and 803 linear feet of 6 and 8 inch diameter wastewater pipe. It will also include 1,172 linear feet of 16 inch diameter bore, 10 wastewater manholes, pavement replacement, appurtenances, and temporary and permanent erosion controls. The work also consists of full-depth street reconstruction in Harris Park Avenue. This street is included within the Alternate 1.

Due to the potential for encountering unknown utilities, a 5% contingency has been included to allow for the expeditious processing of any change orders.

The contract allows 330 calendar days for completion of this project. This project is located within zip code 78705 and is managed by the Public Works Department.
