Authorize award and execution of Amendment No. 1 to various supply and service contracts through the STATE OF TEXAS DEPARTMENT OF INFORMATION RESOURCES cooperative purchasing program for the purchase of computer software and software maintenance and support services to increase the authority for Austin Energy in an estimated amount not to exceed \$120,000, for a revised estimated authorization amount for Austin Energy not to exceed \$9,230,190.

Funding in the amount of \$20,000 is available in the Fiscal Year 2012-2013 Operating Budget of Austin Energy.

**Additional Backup Information**

Information Technology contracts with the State of Texas Department of Information Resources (DIR) provides Austin Energy with access to DIR contracts for computer software and software maintenance and support services.

On September 27, 2012, Council approved the award and authority of various cooperative computer software and software maintenance and support service contracts for Fiscal Year 2012-2013 with the State of Texas DIR for the purchase of computer software and software maintenance and support services.

This request for additional authority will support requirements for the recently approved initiative:

- Ancillary software and software support and maintenance for the Advanced Distribution Management System - Supervisory Control and Data Acquisition (ADMS-SCADA) for Austin Energy's (AE) Distribution System Operations

DIR has continued to provide additional products and services through its program at competitively-bid, discounted prices. The purchasing power of the State of Texas is used to leverage purchasing effectiveness.
