PROPOSAL

Demolish a house that was moved to the current site ca. 1950 from Camp Swift, Texas.

ARCHITECTURE

One-story, rectangular-plan, side-gabled frame house with single and paired 6:6 windows; one-story, rectangular-plan, side gabled addition to the right side.

RESEARCH

City building permits indicate that the house was moved from Camp Swift in 1950. Frank W. Urbis, the father of the first owner and occupant, Helen Scharfe, and her husband, Emil, is listed on the building permit for the relocation of the house. Emil and Helen Scharfe lived here until Emil's death in 1990; Helen Scharfe lived here a number of years longer. Emil Scharfe was a brakeman for the Southern Pacific Railroad.


STAFF COMMENTS
