Additional Backup Information				

This project consists of replacement of approximately 1,352 linear feet of deteriorated water lines, ranging in size from 6-inch to 8-inch, including valves, fire hydrants and appurtenances, and installation of approximately 3,421 linear feet of 8-inch thru 12-inch wastewater line with associated manholes. Also included are creek channel erosion control measures within the Boggy Creek Cherrywood Greenbelt. This project is generally bounded by Schieffer Avenue on the north, Cherrywood Road on the west, Brookview Road on the east, and Clarkson Avenue on the south. Work includes the removal of existing sanitary sewer lines from within the Boggy Creek Cherrywood Greenbelt.

Due to the potential for unknown subsurface conditions and utility conflicts when working in the right of way, a 10% contingency has been included to allow for the expeditious processing of any change orders.

The contract allows 270 calendar days for the substantial completion of this project. This project is located within zip code 78722 and is managed by the Public Works Department.
