EMERGENCY PURCHASE AFFIDAVIT

BEFORE ME, the undersigned authority, personally appeared <u>Greg Meszaros</u>, who being by me first duly sworn, upon oath deposed and stated:

"My name is <u>Greg Meszaros</u>. I am over eighteen (18) years of age. I am the <u>Director</u> for the <u>Austin Water Utility</u> of the City of Austin, Texas. I have personal knowledge of the facts set forth below and am competent and authorized to make this affidavit.

THE SOUTH AUSTIN REGIONAL WASTEWATER TREATMENTPLANT IS RATED AT 75 MGD BUT CURRENTLY CAN ONLY TREAT 50 MGD DUE TO MECHANICAL FAILURES IMPACTING PROCESSES. THE DAILY AVERAGE FLOW IS 42.5 MGD LEAVING LITTLE ROOM FOR FURTHER FAILURE OR FLOW FROM A RAIN EVENT. FAILURE TO TREAT FLOW TO THE PLANT WILL RESULT IN PERMIT FAILURES AND COULD RESULT IN PARTIALLY TREATED SEWAGE OR RAW SEWAGE ENTERING THE RIVER. THIS POSES A POTENTIAL THREAT TO THE ENVIRONMENT AND TO HUMAN HEALTH AND SAFETY. AS SUCH, THE REPLACEMENT OF THE TRAIN A CLARIFIER DRIVE, INSTALLATION OF NEW AIR PIPING TO THE TRAIN B INFLUENT AND RAS CHANNEL AND REPLACEMENT OF THE LIFT STATION 2 PUMP 2 MOTOR OPERATED VALVE AND ACTUATOR ARE CONSIDERED CRITICAL TO PROTECT THE PUBLIC HEALTH AND THE ENVIRONMENT.

"The situation described above is a public calamity that requires the immediate appropriation of money to relieve the necessity of the municipality. I am familiar with state and local laws relating to competition and bidding requirements and realize that willful violations of these laws can subject me to criminal sanctions. I understand further that the Charter of the City of Austin does not exempt emergency purchases from the requirement for competition. However, I believe that the time required to allow competition would place the municipality's residents or property in further danger and that my fiduciary responsibilities to the City of Austin requires that this action be taken immediately."
