<p>Authorize award and execution of a 36-month requirement services contract with DAVID E. BARRIENTOS, dba TSUNAMI CYCLES for bicycle maintenance and repair services for the Austin Police Department, Parks &amp; Recreation Department, and Convention Center in an estimated amount not to exceed \$172,116, with three 12-month extension options in estimated amounts not to exceed \$57,372 per extension option, for a total estimated contract amount not to exceed \$344,232.</p>				
<b>Amount and Source of Funding</b>				
<p>Funding in the amount \$23,155 is available in the Fiscal Year 2012-2013 Operating Budget of the Austin Police Department. Funding in the amount \$5,924 is available in the Fiscal Year 2012-2013 Operating Budget of the Austin Parks and Recreation Department. Funding in the amount \$238 is available in the Fiscal Year 2012-2013 Operating Budget of the Austin Convention Center Department. Funding for the remaining 30 months of the original contract period and extension options is contingent upon available funding in future budgets.</p>

## Additional Backup Information

This contract will provide bicycle repair and maintenance services on an as-needed basis for the Austin Police Department (APD), Austin Parks and Recreation Department (PARC), and the Austin Convention Center Department (ACCD).

APD Bicycle Units patrol several areas within the Austin City limits, including the downtown area and along the green belt or hike and bike trails. PARC Park Rangers patrol park land areas including the downtown parks areas and along the greenbelts, nature preserves, and hike and bike trails. ACCD Security staff patrol the surrounding area of the Convention Center, Palmer Events Center, and three associated parking garages.

The Contractor will provide services on-site at a location designated by each department and at the Contractor's place of business.
