Authorize award and execution of a 12-month service requirements agreement with GOODWILL INDUSTRIES OF CENTRAL TEXAS for mattress collection and recycling processing services for the Austin Resource Recovery Department in an amount not to exceed \$277,800, with five 12-month extension options in an estimated amount not to exceed \$277,800 per option, for a total estimated contract amount not to exceed \$1,666,800.

Amount and Source of Funding

Funding in the amount of \$138,900 is available in the Fiscal Year 2012-2013 Operating Budget of the Austin Resource Recovery Department. Funding for the remaining six months of the original contract period and for the extension options is contingent upon available funding in future budgets.

Additional Backup Information

This contract is for mattress collection and recycling processing services to work collaboratively with Austin Resource Recovery (ARR) to reduce the quantity of mattresses and box springs being disposed of in landfills. The contractor will provide personnel, vehicles and necessary equipment for the prompt collection and transport of used mattresses and box springs generated by ARR's residential customers. The contractor will follow ARR's Bulky Collection route schedule, working concurrently with ARR's Bulky Collection crews on each route, and will also provide on-call collection service to fulfill out-of-cycle service requests from ARR customers. The contractor will also operate a processing facility to receive, pre-treat and deconstruct mattresses and box springs; bale and store the separated commodities; and market and ship the materials to downstream processors.
