

**ORDINANCE NO.**

1 **AN ORDINANCE AMENDING CITY CODE SECTION 12-4-64(D) TO MODIFY**  
2 **THE SPEED LIMITS ON CERTAIN SEGMENTS OF AIRPORT BOULEVARD,**  
3 **TO ADD A 20 MILES PER HOUR SCHOOL ZONE ON A SEGMENT OF**  
4 **AIRPORT BOULEVARD FOR STUDENTS ATTENDING RIDGETOP**  
5 **ELEMENTARY SCHOOL, AND TO PROVIDE FOR EMERGENCY PASSAGE.**

7 **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

8 **PART 1.** Section 12-4-64(D) (*Table of Speed Limits*) is amended to read:

9 Airport Boulevard from Lamar Boulevard (North) to 162 feet south of 53<sup>rd</sup> Street  
10 (East) [I.H. 35 (North) West Frontage Road]. (40 mph)

11 **PART 2.** Section 12-4-64(D) (*Table of Speed Limits*) is amended to add:

12 Airport Boulevard from 162 feet south of 53<sup>rd</sup> Street (East) to 55 feet south of 52<sup>nd</sup>  
13 Street (East) (35 mph)

14 Airport Boulevard from 258 feet south of 51<sup>st</sup> Street (East) to 185 feet south of 50<sup>th</sup>  
15 Street (35 mph)

16 Airport Boulevard from 55 feet south of 52<sup>nd</sup> Street (East) to 258 feet south of 51<sup>st</sup>  
17 Street (East) (20 mph school zone for students attending Ridgetop Elementary  
18 School)

19 Airport Boulevard from 185 feet south of 50<sup>th</sup> Street (East) to I.H.35 (North) West  
20 Frontage Road (40 mph)

21 **PART 3.** The amendments made in this ordinance are based on the results of a traffic  
22 engineering investigation, or “speed study,” attached as Exhibit “A”.

23 **PART 4.** The amendments made in this ordinance shall be incorporated in alphabetical  
24 order and the existing entries reordered accordingly.

25 **PART 5.** Council finds that school is in session, and the need for a school zone at this  
26 site constitutes an emergency. Because of this emergency, this ordinance takes effect

1 immediately on its passage for the immediate preservation of the public peace, health and  
2 safety.
