**Summary of Complaint** Caller reported loud music coming from the bar. Officers responded. No additional information is available.

**Results:** During the period of March 26, 2012 through March 26, 2013, there were 8 calls classified as disorderly conduct calls for service and one for assist complainant (also noise related) at 817 West 5<sup>th</sup> St. One of these calls is not included in the list because it relates to road construction noise near the bar.

**Note:** It is not possible to isolate “noise” calls, so “disorderly conduct” (which includes noise-related calls) is provided instead.
