1 AN ORDINANCE AMENDING ORDINANCE NO. 20061116-055, WHICH
 2 ADOPTED THE EAST RIVERSIDE/OLTORF COMBINED NEIGHBORHOOD
 3 PLAN AS AN ELEMENT OF THE IMAGINE AUSTIN COMPREHENSIVE
 4 PLAN, TO CHANGE THE LAND USE DESIGNATIONS ON THE FUTURE
 5 LAND USE MAP FOR CERTAIN PROPERTIES LOCATED IN THE
 6 NEIGHBORHOOD PLAN AREA.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

10 PART 1. Ordinance No. 20061116-055 adopted the East Riverside/Oltorf Combined
 11 Neighborhood Plan as an element of the Imagine Austin Comprehensive Plan.

12 PART 2. Ordinance No. 20061116-055 is amended to change the land use designations
 13 on the future land use map attached as Exhibit "A" and incorporated in this ordinance,
 14 and described in File NPA-2012-0021.02 at the Planning and Development Review
 15 Department for properties as follows:

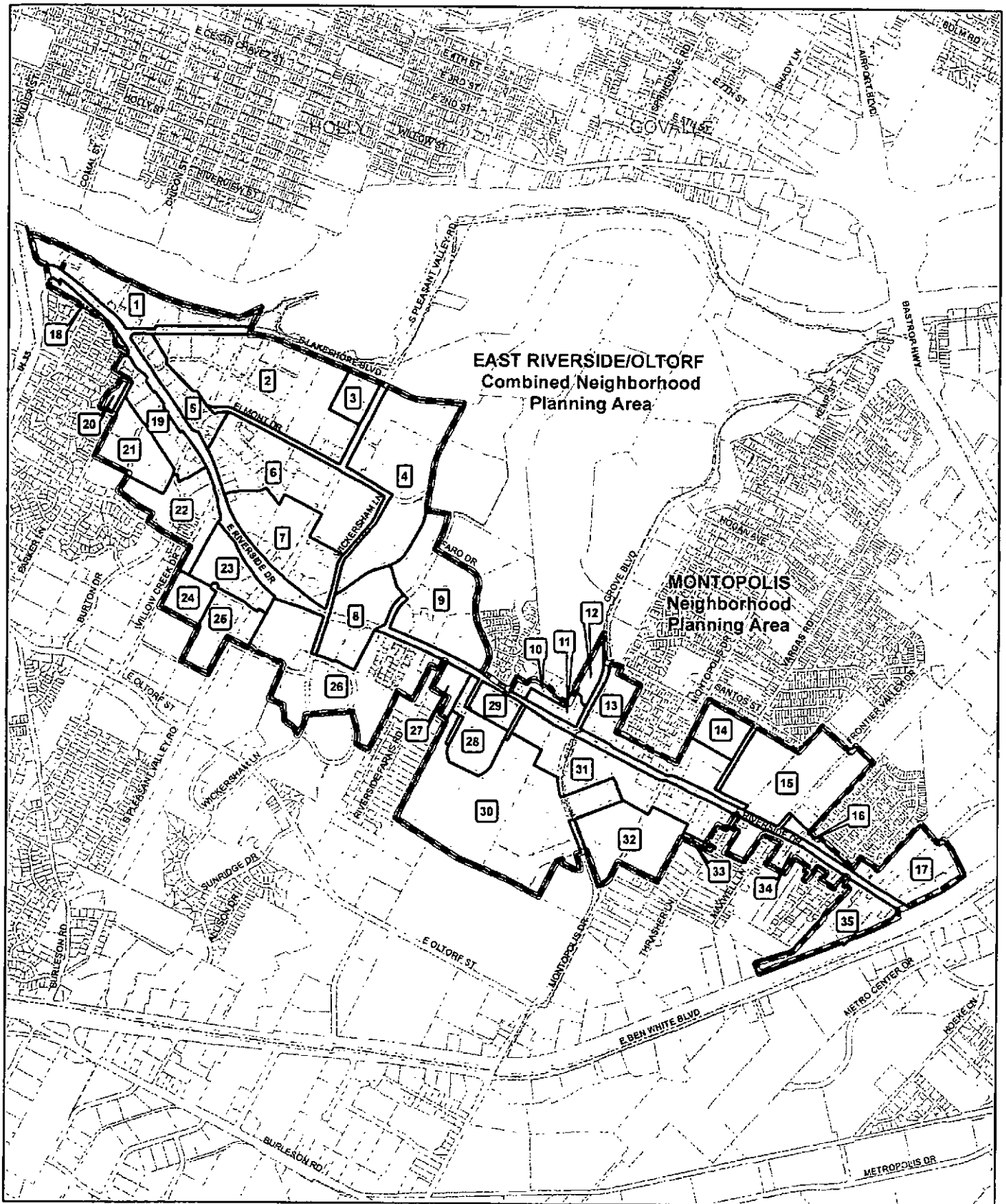
