PROPOSAL

Construct a new 6-foot metal picket fence across the front and sides of the property.

PROJECT SPECIFICATIONS

The applicant proposes the construction of an open picket metal fence around the front and sides of the property, with a gate at the central walkway to the front door. The fence will be painted black and will have alternating heights of pickets, the tallest of which will be 6 feet.

STANDARDS FOR REVIEW

The Commission's Standards for Review of applications for Certificates of Appropriateness include:

- Do not destroy the distinguishing original qualities or character of a building, structure, or site and its environment. Avoid the removal or alteration of any historic material or distinctive architectural features.
- Recognize all buildings, structures, and sites as products of their own time. Do not construct alterations which have no historical basis and which seek to create an earlier appearance.
- Contemporary design for alterations and additions to existing properties are appropriate when such alterations and additions do not destroy significant historic, architectural, or cultural material and such design is compatible with the size, scale, color, material, and character of the property, neighborhood, or environment.

COMMITTEE RECOMMENDATIONS

The Committee recommended denial of the fence at a height of 6 feet with a recommendation that the fence be reduced to a maximum height of 4 feet.

STAFF RECOMMENDATION

Deny the application for a 6-foot fence and require the applicant to install a fence of no higher than 4 feet.
