AN ORDINANCE WAIVING CERTAIN FEES AND REQUIREMENTS UNDER CITY CODE CHAPTER 14-8, CERTAIN OTHER FEES AND REQUIREMENTS, AND AUTHORIZING PAYMENT OF CERTAIN COSTS FOR THE CITY CO-SPONSORED GREATER EAST AUSTIN YOUTH ASSOCIATION'S 2013 JUNETEENTH PARADE AND CELEBRATION WHICH WILL BE HELD ON JUNE 15, 2013.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:
