B. RESIDENTIAL DESIGN AND COMPATIBILITY STANADARD

B-1 2012-047087PR Roberto & Elizabeth Sanchez 814 E 46th Street

MODIFICATION REQUESTED: The applicant has requested a modification to allow a F.A.R. increase from the maximum development permitted in Chapter 25-2 of the Land Development Code, Section 2.1 Subchapter F: Residential Design and Compatibility Standards from the allowable 40% (2529.6 sq ft.) to 50% (3162 sq ft) for an addition to a single family residence in a SF3-NCCD-NP zoning district.

COMMISSION'S DECISION: The public hearing was closed on Commissioner Lucy Katz motion to APPROVE with conditions to meet the off street parking requirements per the North Hyde Park NCCD. Commissioner Chuck Mains second on 5 to 2vote.

B-2 2012-080463PR Tim Cuppett for Steve & Ellen Miura 1502 Lorrain Street

MODIFICATION REQUESTED: The applicant has requested a modification to allow a F.A.R. increase from the maximum development permitted in Chapter 25-2 of the Land Development Code, Section 2.1 Subchapter F: Residential Design and Compatibility Standards from the allowable 40% (4216.8 sq ft) to 43.2% (4555 sq ft) for an addition to an existing single family residence in a MF-3 zoning district.

COMMISSION'S DECISION: The public hearing was closed on Commissioner Chuck Mains motion to APPROVE. Commissioner Karen McGraw second on a 7 to 0 vote. APPROVED
