SPECIAL CALLED MEETING/RETREAT APRIL 27, 2013

A. NEW BUSINESS

1. Introductions

Brief introductions were given by all present.

2. Planning 101

Garner Stoll gave a presentation on factors that go into decision making and planning principles, along with the roles and responsibilities of elected policy makers, Planning Commission members, staff and members of the public.

Questions/comments from Board members:

- The importance of planning background/education and the best ways to obtain
- Commitment to the job as a form of education
- Staff reports are we getting everything we need? New information is often presented at last minute without time for review – establish a firm submittal deadline – PC authority to postpone an item if too much additional information is presented without time for review
- If policy isn't working or not feasible what to do then?
- When to use certain tools
- Code/Comprehensive Plan rewrites and frequency of updates
- Attendance at State planning conferences
- Criteria for review of Imagine Austin Comprehensive Plan Compliance Review
- Request for books/publications that would be helpful for education/training
- When to make appeals to City Council vs. recommendations is there a ready reference?

3. Basic Review Of Roberts Rules Of Order

Deborah Thomas gave a presentation on the basic rules of Roberts Rules of Order.

Questions/comments from Board members:

- Cheat sheet with basics would be very helpful
- Process for substitute motions
- Structure rules in a way that works best for the board
- Proper protocol after a public hearing is closed
- Denial of staff recommendations
- Motions before or after a discussion
- Process for friendly amendments
- Motions to postpone
- Recording of amended votes in written meeting minutes

4. Purpose, Scope, Roles and Responsibilities of Planning Commission and City Processes

Greg Guernsey gave presentations on Charter provisions and functions of the Commission. Deborah Thomas and David Sorola gave presentations on by laws review, Commission rules and procedures and ex-officio member roles.

- Do you vote or appoint members to other committees?
- Staff support not provided for working groups
- Amendments to rules of procedure Greg Guernsey will research
- Value of ex-officio members
- Clarification on procedure to change ex-officio roles and responsibilities Deborah Thomas will research
- Allowing ex-officio discussion in areas not related to their expertise and after a motion has been made
- Mechanisms to make meetings more efficient
