Authorize award and execution of a 36-month requirements supply contract with BAYSCAN TECHNOLOGIES, to provide barcode labels and ribbons for the Austin Police Department in an estimated amount not to exceed \$34,327, with two 12-month extension options in an estimated amount not to exceed \$12,605 for the first extension option and \$13,235 for the second extension option, for a total estimated contract amount not to exceed \$60,167.

Amount and Source of Funding

Funding in the amount of \$3,630 is available in the Fiscal Year 2012-2013 Operating Budget of the Austin Police Department. Funding for the remaining 32 months of the original contract period and extension options is contingent upon available funding in future budgets.

Fiscal Note

There is no unanticipated fiscal impact. A fiscal note is not required.

Additional Backup Information			

This contract will provide barcodes and labels for the Austin Police Department (APD) Evidence Unit. The APD Evidence Unit receives approximately 7,500 new items of evidence and/or property each month. Within the first 24-36 hours, each bar code is scanned no less than 5 times. This covers intake of the evidence to first initial storage location. Throughout the life of a piece of evidence, a bar code label will be scanned and utilized numerous times to update tracking and ensure accountability of the item. The bar code labels are critical to the management of property and evidence within APD.

Every item of evidence, as well as all non-evidentiary property, submitted to the Evidence Unit is marked with a label. Each label consists of a bar code, brief description of the item, the offense number it relates to, and a specific number identifying the item. These labels allow the Evidence Unit staff to conduct real time updates documenting the movement of evidence within the department and allows for the real time update of the storage locations within APD's warehouse. In addition, bar code labels are utilized to mark shelving which facilitates the speed at which these real time updates take place.
