## REGULAR MEETING Wednesday, April 10, 2013

The Early Childhood Council (ECC) convened for a regular meeting on Wednesday, April 10, 2013, at City Hall, 301 West Second Street, Austin, Texas.

The Meeting was called to order by Chair Holder at 9:05 AM.

- 1. INTRODUCTIONS: Chair Holder asked guests to introduce themselves.
