Background

- 1999 CMFRO adopted
- 2010 URO adopted
- 2012 Administrative Rules amended
- 2012 URO into effect
- 2013 URO amended

Where we are...



Ordinance Amendments

Expanded to include:

- Recycling at all businesses in Austin by Oct 2016
- Composting at all food service establishments by Oct 2017



GOAL: **To amend the Chapter 15-6 Administrative Rules through a cooperative stakeholder process**





Roles and Responsibilities

Committee serves as voting body

- Listens to and considers public input
- Reviews documentation provided by stakeholders and staff
- As a body, makes recommendation to ZWAC

Staff serves as a resource

- Communicates to all stakeholders – meeting notices, notes, etc
- Identifies impact to city operations, legality, etc
- Researches issues
- Provides staff recommendation on:
 - Committee recommendation to ZWAC
 - ZWAC Recommendation to Council



Roles & Responsibilities

Stakeholders provide input to Committee:

- Impact of ordinance to operations, costs, customers, markets, etc
- Suggestions to modify recommendations being considered
- Stakeholder “needs” to implement the ordinance and make it effective

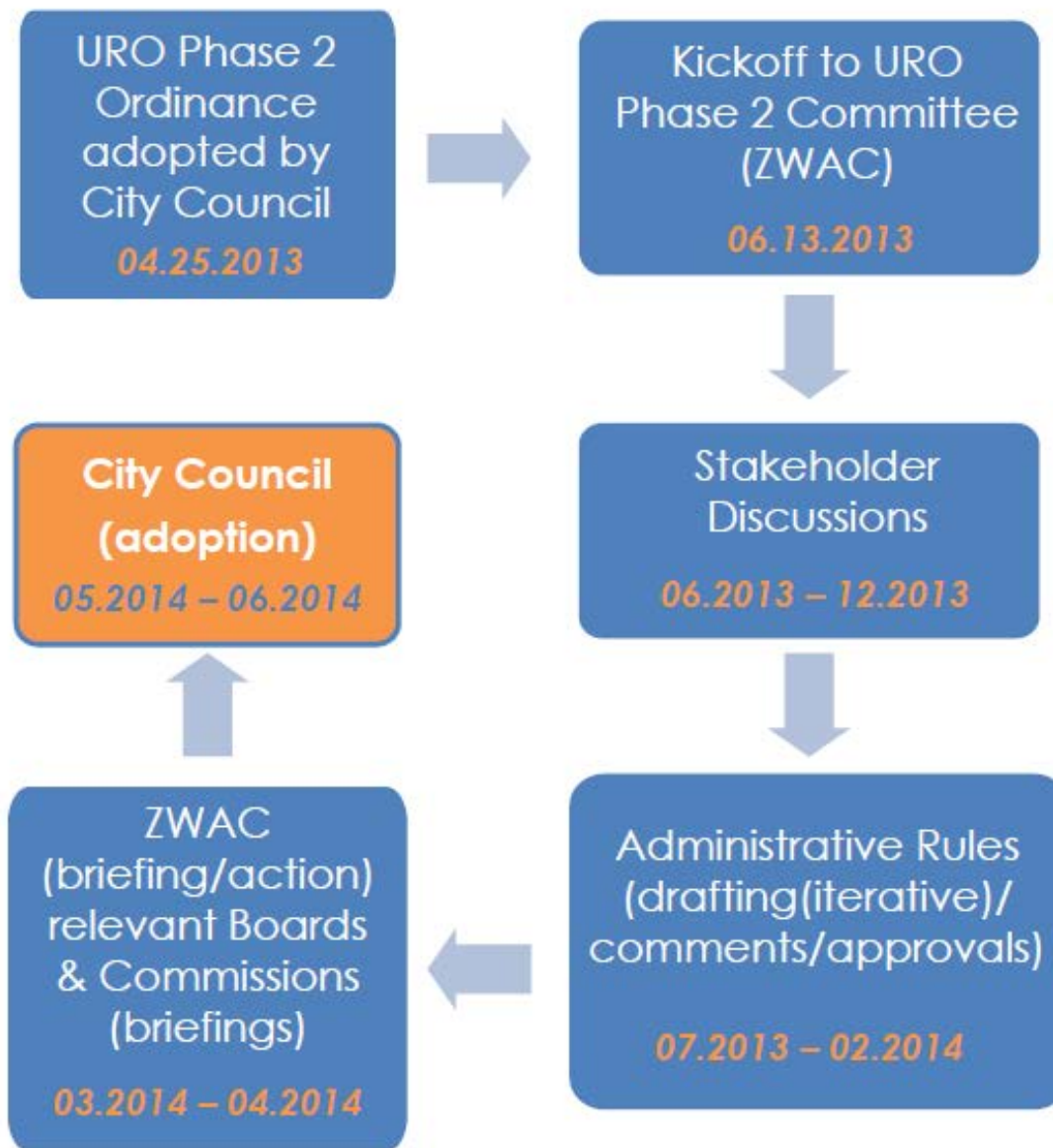

- Current Administrative Rules

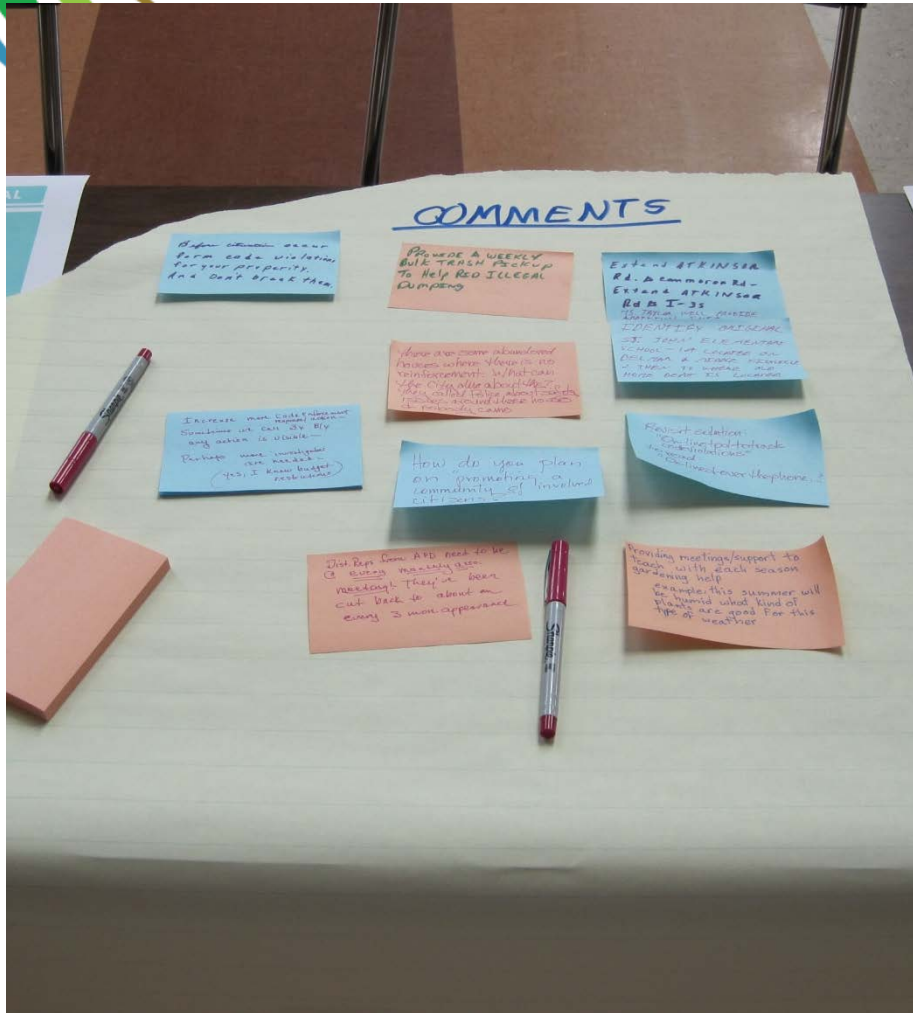
What we need:
