**ANALYSIS** / **ADDITIONAL INFORMATION**: After the adoption of the Austin Bicycle Master Plan in June 2009, the City received a federal grant to construct showers at City owned work sites. Keeping in line with goals of the Master Plan, this project will aid the City of Austin in its efforts to reduce air pollution and traffic congestion through encouraging bicycling for commuting to work, day time trips and linking bicycling to transit use for transportation.

Work consists of installing two shower facilities; one within the existing Waller Creek Center's first floor and the second behind the PARD headquarters, which will be a free standing facility. The showers will be utilized by the City of Austin employees.

Due to the potential for unforeseen site and previous building conditions, a 10% contingency has been included to allow for the expeditious processing of any change orders.

The contract allows 150 calendar days for completion of this project. This project is located within zip codes 78701 and 78704 and is managed by the Public Works Department.
