# Subject

Authorize award and execution of a 36-month requirements Service contract with MCCOURT & SONS EQUPMENT, INC., for the rental of a front-end loader and trommel screener for the Austin Water Utility in an amount estimated not to exceed \$192,000, with two 12-month extension options in an estimated amount not to exceed \$64,000 each for a total contract amount estimated not to exceed \$320,000.

# Amount and Source of Funding

Funding in the amount of \$16,000 is available in the Fiscal Year 2012 – 2013 Operating Budget of the Austin Water Utility. Funding for the remaining 36 months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract with McCourt & Sons Equipment, Inc., is for the rental of a front-end loader and trommel screener for the Austin Water Utility's (AWU) Hornsby Bend Biosolids Management Plant. The equipment will be used to move material that will be a wet and dry chipped and composted mixture of yard waste, biosolids, dirt, and treated sludge. The trommel screener will be used to separate materials by size. Though the primary intention for the use of this equipment is for screening and loading of Dillo Dirt, it provides flexibility for use in the operations, as well. This contract includes provisions for full preventative maintenance and repair services by the contractor. The rental contract will allow for the Utility's Dillo Dirt operations to immediately respond to increased production demands or maintenance problems with any existing front-end loaders. The rental of this equipment as a backup for current operations as will only be rented and used as needed.
