# HISTORIC LANDMARK COMMISSION JUNE 24, 2013 DEMOLITION AND RELOCATION PERMITS HDP-2013-0299 1310 GARDEN STREET / 70 NAVASOTA STREET

#### **PROPOSAL**

Demolish a ca. 1928 house and addition that was originally used as a neighborhood grocery store.

#### ARCHITECTURE

One-story, rectangular-plan, front-gabled frame house with a partial-width, front-gabled independent porch on plain, square wood posts; 1:1 fenestration; the siding appears to be sheets of interior paneling which has been applied to the exterior and painted. There is a one-story, side-gabled addition to the rear of the house with a full-width, shed-roofed, independent porch. This addition carries the address of 70 Navasota Street and was historically used as a neighborhood grocery store.

#### RESEARCH

There is an indication in city records that a sewer permit was issued for this address in late 1928, but the permit no longer exists. The late 1928 date coincides with city directory listings, which do not list either address until the edition of 1930-31 (the 1929 directory information was compiled in 1928, and the houses were not extant at that time). The main house, facing Garden Street, had an original address of 1324 Garden Street, and was the home of Charles A. and Sallie Davis, who operated a grocery store in the addition, which had an address of 70 Navasota Street. Their business was known as the Sanitary Grocery, and they were in business here until around 1943. Charles A. Davis is believed to have been raised in Williamson County, Texas - the 1900 U.S. Census report shows him and Sallie as living on a rented farm there. They were living in Stamford, Texas in 1920, where they operated a restaurant, and then were shown in Austin by 1930, where Charles is listed as a night watchman for a construction company, so he had his grocery business in addition to his outside job. The census reports do not show the couple as having a son, but, perhaps entirely coincidentally, another Charles A. Davis was the proprietor of Austin's Sani-Products Company, a potato chip manufacturer, (with a curiously coincidental name to the Sanitary Grocery) in the 1940s, but there is no evidence to show that the two were related.


Around 1943, the Davises moved next door to a bungalow at 72 Navasota Street, and Harry S. Boatright, a construction worker for the State Highway Department, is shown as the owner of the house, while Sybil Smith, who also lived in the house, operated the grocery store. The Boatrights and Sybil Smith lived here until around 1948. By 1949, the house facing Garden Street was shown as vacant, and Walter T. and Jessie Huff lived at 70 Navasota Street, where they operated a grocery. Walter T. Huff was also a long-time janitor at the General Land Office. They lived here until around 1960. They moved into the house around 1953, and kept the grocery at 70 Navasota Street. After the Huffs moved away, the house became a rental unit during the 1960s, and there is no evidence of a grocery store at the Navasota Street address after the Huffs moved away. Victor and Julia Cruz moved into the house in the late 1960s as renters, and by the mid-1970s, they were shown as the owners of the house. Victor Cruz was a foreman for Tony's Tortilla Factory on E. 7th Street until the mid-1970s, then went to work for Matt's El Rancho Restaurant, when it was still located at 1st (Cesar Chavez) and San Jacinto.

# STAFF COMMENTS

The house does not appear in any City survey.

# STAFF RECOMMENDATION

Release the demolition permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

#### **BIOGRAPHICAL NOTES:**

#### Charles A. and Sallie Davis (ca. 1930 – ca. 1943)

Charles A. and Sallie Davis appear in the 1940 U.S. Census at 1324 Garden Street, a house they owned, and which was worth \$3,000. Charles A. Davis was then 67 years old, had been born in Texas, and was a merchant. Sallie Davis was then 65 years old, and had been born in Texas. She had no occupation listed in the census report. The 1930 U.S. Census also shows Charles and Sallie Davis at this address; he was listed as a night watchman for a construction company. The 1920 U.S. Census shows them as the renters of a house at 80 San Marcos Street, along with their daughter, Virgie, then an 18-year old stenographer for an insurance company. Charles Davis is listed as a clerk in a department store. The 1910 U.S. Census shows the family living in Stamford, Jones County, Texas, where Charles A. Davis was the proprietor of a restaurant. Besides Virgie, they had an older daughter, Viola (or Vida), who does not appear in later census reports with the family. The 1900 U.S. Census shows Charles, Sallie, and Vida living on a rented farm in Williamson County, Texas.

Charles A. Davis died in Travis County in 1949. His obituary lists him as a retired merchant and he was living in Hyde Park at the time of his death. He was buried in Leander, Texas. His wife, Sallie, outlived him, but no obituary appeared in the Austin newspapers for her.

.T. (SHORTY) HUF1 W. T. (Shorty), Huff, 77, of 1607 Waterston, died in a local hospital on Sunday. He had been a resident of Austin for the past 30 years and employed for 20 years in the Texas General Land Office prior to his retirement.
