## 1. CITIZEN COMMUNICATION

2 citizens spoke during the opportunity for citizen communication.

- Mr. Scott Johnson spoke about the anticipated Special Events Ordinance and event recycling rebate. Mr. Johnson suggested that staff develop a video about how to recycle right.
- Mr. Andrew Dobbs, Texas Campaign for the Environment, commented about amounts of trash and recyclables in the South Congress area during a recent event.

## 2. APPROVAL OF APRIL MINUTES

Minutes for the regular meeting of April 10, 2013 were approved on a Commissioner Dave Sullivan motion, Commissioner Brent Perdue second on a 4-0-1 vote. Commissioner Cathy Gattuso abstained from the vote. Commissioners Daniela Ochoa Gonzalez and Fayez Kazi were absent.

## 3. NEW BUSINESS

### a. Presentation—Special Events Ordinance Update

No citizens spoke about the agenda item.

Mr. Gordon Derr, Austin Transportation Department Assistant Director, presented updates on the anticipated Special Events Ordinance and answered Commissioners' questions. Gena McKinley and Annette Moreno answered questions about recycling rebates for events and issues related to diversion at large events.

### b. Discussion and Action – Austin Resource Recovery Advertising Expenditures

No citizens spoke about the agenda item.

Phil Tindall, Austin Resource Recovery, presented the proposal to authorize recurring expenditures necessary to conduct routine City of Austin business with multiple agencies and vendors in separate amounts not to exceed \$155,000. Phil Tindall and Gena McKinley, Austin Resource Recovery, answered Commissioners' questions.

The proposal was approved on a Commissioner Brent Perdue motion, Commissioner Dave Sullivan second on a 5-0-0 vote. Commissioners Daniela Ochoa Gonzalez and Fayezi Kazi were absent.

**c. Discussion—Austin Resource Recovery Financial Forecast FYs 2014-2018**
