

Independent Citizens Redistricting Commission (ICRC)
 Optional Meeting Schedule for Discussion
 May 31, 2013

The full ICRC has the authority to determine a meeting schedule of its choosing. This document provides an optional meeting schedule for discussion. Suggested locations have been reserved and assessed for charter compliance, availability, accessibility, capacity, Channel 6 taping compatibility, parking, and cost. The schedule reflects three initial meetings for the selection of the final six ICRC members, with remaining meetings dedicated to public input and ICRC votes, for a total of 20 meetings.

Regarding charter compliance, City Charter Article II Section 3(K)(7) requires the ICRC to receive public input before the ICRC votes on and approves a preliminary plan; there must be at least two such public hearings in each of the four Travis County Commissioner Precincts, for a total of eight public hearings, before the vote on a preliminary plan. Following a vote on a preliminary plan, there must be four additional public hearings with at least one hearing in each of the four Travis County Commissioners Precincts before the vote on a proposed final plan. Following a vote on a proposed final plan, there must be two additional public hearings --- one north of Lady Bird Lake and one south of Lady Bird Lake --- before the vote on a final plan no later than December 1, 2013.
