PROPOSAL

Demolish a ca. 1929 house.

ARCHITECTURE

One-story, rectangular-plan, hipped-roof, frame house with a partial width inset porch on the right side of the front façade; non-historic front-gabled dormer in the center of the front roof; fenestration includes a Queen Anne-style front window with a multi-light transom; otherwise windows exhibit a 1:1 pattern.

RESEARCH

The house appears to have been built around 1930; the first owners and occupants were Andrew J. Mears and his wife, Katherine, who lived here from around 1929 to around 1943. Andrew J. Mears had been a farmer in Bosque County, Texas prior to moving to Austin. He worked at the State School for the Deaf, where his son, Clifford, was a student. Katherine Mears worked as a seamstress at the State School for the Deaf. Clifford was employed as a clothes presser and tailor as an adult; his younger sister, Gladys went on to become a teacher at the State School for the Deaf.

After the tenancy of the Mears family, the house was owned and occupied by Carl and Annie Ekstrom. The Ekstroms had lived on Crockett Street in South Austin prior to moving into this house; they lived here from around 1943 until around 1969, when Annie Ekstrom passed away. Carl Ekstrom then moved to a house on Jim Hogg Avenue, where he died in July, 1970. Carl Ekstrom worked as a coffee roaster for the John Bremond Company for the entire time he lived in this house; Annie Ekstrom was a housekeeper in the Brown Building. The house was converted to a duplex in 1972; tenants included a Motorola employee and a construction worker.


STAFF COMMENTS

The house is listed in the Comprehensive Cultural Resources Survey (1984) but with no priority ranking for research.

STAFF RECOMMENDATION

Encourage relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

BIOGRAPHICAL NOTES:**Andrew J. and Katherine Mears (ca. 1929 – ca. 1943)**

Andrew J. and Catherine Mears appear in the 1920 U.S. Census as farmers in Bosque County, Texas near the community of Walnut Springs. They owned their farm. Andrew J. Mears was then 27 years old and had been born in Texas. Catherine Mears was then 26 and had been born in Texas. They had children: Andrew J., Jr., 5, Clifton C., 3, and Gladys, 1. With them also lived Catherine Mears' brother, John K. Waddington, 14.

The Mears family shows up in the 1930 U.S. Census as the owners of this house, which was worth \$1,500. A.J. Mears was then 37 and is listed as an engineer at the Deaf School. Kate Mears was 35 and had no occupation listed. Their children were: Jack, 14; Clifton, 13; Gladys, 11; L.S., 9; and Dorris, 3. All the children had been born in Texas; none had an occupation listed.

The 1940 U.S. Census shows A.J. and Catherine Mears at this address. Their house was worth \$3,000. A.J. Mears was the manager of a tourist court; Catherine Mears was a seamstress at the Texas School for the Deaf. Their son Clifton was a tailor at a dry cleaner's establishment, daughter Gladys was a teacher at the state school, and daughter Doris Jean had no occupation listed.

Andrew Mears died August 4, 1975 in Mansfield, Tarrant County, Texas.

Carl and Annie Ekstrom (ca. 1943 – ca. 1970)

Carl and Annie Ekstrom appear in the 1940 U.S. Census, at 305 Crockett Street in Austin, a house they owned, and which was worth \$2,100. Carl Ekstrom was then 53, had been born in Texas, and was a coffee roaster for a wholesale coffee company. Annie Ekstrom was then 52, had been born in Texas, and did laundry for a private family. With them lived Annie's two sons, Clifford Ball, 25, a clerk in a retail drug store; and Harry Ball, 23, a foreman in a building construction firm. Lillie Reckinwald, 28, listed as a niece in the census report, had no occupation listed. The Ekstroms also had a boarder, Madeline Young, 19, a waitress in a night club. The 1930 U.S. Census shows the Ekstrom family living at 303 Crockett Street; their house was worth \$1,500. Carl Ekstrom is listed as a coffee roaster for the John Bremond Company. Annie Ekstrom did not have an occupation listed; neither did her two sons.

Mrs. Annie Ekstrom, 83, of 902 West Live Oak St., died in a local hospital Wednesday evening. Survivors include her husband, Carl Ekstrom of Austin, and one son, Clifford Ball of Austin.
