  - Mirusha Yogarajah, intern for Asian American Resource Center, read a
    resolution requesting that Asian Americans are fully included in all the
    policies and programs of the City of Austin and are offered an equal voice
    in the decisions that impact them as members of the larger Austin
    Community.

- ii. Ramey Ko, member of President Obama's Advisory Commission on Asian Americans & Pacific Islanders, spoke on the recognizing the Asian American community as the fastest growing ethnic group in the Austin community for the past 10 years. Mr. Ko stated that right now Asian Americans are being left out of the critical conversations for the Austin community.
- iii. Leslie Varghese, Executive Director and General Counsel to the Asian American Resource Center, spoke on the necessity of the City of Austin to provide services to the underserved Asian population.
- iv. The Commission considered and approved a resolution recommending full support by Austin City Council for Asian Americans to be included in all of the policies and programs of the City of Austin and to be offered an equal voice in the decisions that impact them on a 5-0 vote, Commissioner Cortez motion, Commissioner Brenner second. Commission member Lofton was absent
