a. STAFF BRIEFING: Watershed Protection Amendments – Consider an ordinance amending Chapter 25 to improve creek and floodplain protection; prevent unsustainable public expense on drainage systems; simplify development regulations where possible; and minimize the impact on the ability to develop land. City Staff: Matt Hollon, Watershed Protection Department, 974-2212, Matt.Hollon@austintexas.gov (Discussion)

Matt Hollon presented an overview of changes to Chapters 25 that relate to creek and floodplain protection, drainage, and development. Mr. Hollon explained that the existing regulations have been in place since 1986, with no major changes, and are in need of significant updates. The proposed changes would protect streams in the eastern part of Austin in a fashion similar to how western streams are currently protected. The changes focus on creek protection, floodplain protection, stormwater controls, and development regulations.

Mr. Hollon indicated that he would return in July for the subcommittee to take action. No action was taken.

#### 5. OTHER BUSINESS

a. **Policy Issues and Priorities Standing Item: Affordability** – Discuss issues around affordability in the City of Austin (Sponsor: Commissioner Anderson; Co-Sponsor: Commissioner Oliver) (Discussion and/or Possible Action)

Commissioners broadly discussed affordable housing and affordability issues in Austin. Discussion centered on rental vs. ownership affordability, dispersion of affordable housing around Austin, and gentrification.

No action was taken.

b. Update on potential upcoming and current code amendments, and the amendment process - City Staff: Greg Dutton, Planning and Development Review Department, 974-3509, Greg.Dutton@austintexas.gov (Discussion and/or Possible Action)

Greg Dutton gave a brief update of ongoing and upcoming code amendments. Commissioners examined a list of existing code amendments to determine if these should be pursued or if they might be rolled into the comprehensive code rewrite.

A motion was made to roll several code amendments (but not those related to stealth dorms or the stealth dorm working group) into the comprehensive code rewrite, by Commissioner Anderson, seconded by Commissioner Oliver. Vote: 6-0.
