

Late Backup**ORDINANCE NO. 20130808-007**

AN ORDINANCE ORDERING A SPECIAL ELECTION TO BE HELD IN THE CITY OF AUSTIN ON NOVEMBER 5, 2013, FOR THE PURPOSE OF AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. A special election shall be held in the City of Austin on November 5, 2013, for the voters to consider the issuance of general obligation bonds.

PART 2. The qualified voters shall vote for or against the bond proposition as set forth in Part 1 of Ordinance No. 20130808-007A, attached as Exhibit A and incorporated as part of this ordinance.

PART 3. The proposition shall appear on the official ballot in substantially the form set forth in Part 2 of Ordinance No. 20130808-007A.

PART 4. The election shall be conducted between the hours of 7:00 a.m. and 7:00 p.m. The precincts and locations of the election day polling places; the dates, hours, and locations of the early voting places; and the names of the officers appointed to conduct the election are provided in Exhibits A-G attached and incorporated as a part of this ordinance.

PART 5. A direct electronic recording voting system, as the term is defined in Title 8 of the Texas Election Code, shall be used for early voting and for voting conducted on election day. The central counting station is established at the Travis County Elections Division, 5501 Airport Boulevard, Austin, Texas.

PART 6. Notice of this election shall be given by posting and publishing a copy of this ordinance in both Spanish and English. The posted notice shall be posted in three public places and at the City Hall notice kiosk not later than the 21st day before election day. The copy of this ordinance posted at City Hall shall be accompanied by a cover page, at the top of which shall appear the words "A MUNICIPAL SPECIAL ELECTION, NOVEMBER 5, 2013." Notice of this election shall be published, not earlier than the 30th day before the date of the election, in a newspaper of general circulation on the same day in each of two successive weeks, with the first publication occurring before the 14th day before the date of the election.

PART 7. In accordance with Chapter 271 of the Texas Election Code, the November 5, 2013 municipal election may be held jointly with the various political subdivisions that share territory with the City of Austin and that are holding elections on that day. The City Clerk may enter and sign joint election agreements with other political subdivisions for this purpose, and their terms as stated in the agreements are hereby adopted.

PART 8. The Council finds that the need to immediately begin required preparations for this election constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health, and safety.

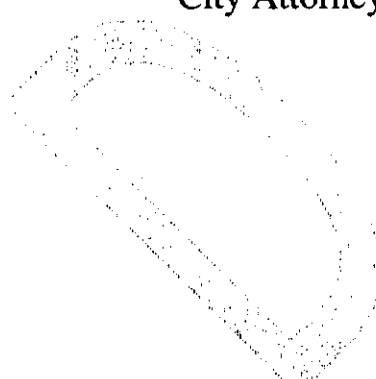

ORDENANZA NO. 20130808-007

ORDENANZA CONVOCANDO UNA ELECCIÓN ESPECIAL EN LA CIUDAD DE AUSTIN EL 5 DE NOVIEMBRE, 2013, PARA AUTORIZAR LA EMISIÓN DE BONOS DE OBLIGACIÓN GENERAL, Y PARA DECLARAR UNA EMERGENCIA.

POR ORDEN DEL CONSEJO DE LA CIUDAD DE AUSTIN:

PARTE 1. Se efectuará una elección especial en la Ciudad el 5 de Noviembre, 2013 para que los votantes consideren la emisión de bonos de obligación general. .

PARTE 2. Los votantes cualificados votaran a favor o contra la proposición de bonos de acuerdo con lo detallado en la Parte 1 de la Ordenanza No. 20130808-007A, adjuntada como Adjunto A e incorporada como parte de esta ordenanza.

PARTE 3. La proposición aparecerá en la boleta oficial substancialmente en la manera detallada en la Parte 2 de la Ordenanza No. 20130808-007A.

PARTE 4. La elección se efectuará durante las horas de las 7:00 a. m. a las 7:00 p.m. Los precintos y lugares de los sitios de votación el día de la elección; las horas, fechas, y sitios de la votación adelantada; y los nombres de los oficiales nombrados para efectuar la elección se indican en los Adjuntos A-G que van adjuntos a lo presente y que se incorporan como parte de esta ordenanza.

PARTE 5. Un sistema electrónico indicador directo de votación que se defina en el Título 8 del Código Electoral de Texas se usará para la votación adelantada y en la votación el día de la elección. La Estación Central Para Contar Votos se ubicará en Travis County Elections Division, 5501 Airport Boulevard, Austin, Texas

PARTE 6. El aviso de esta elección se hará fijando y publicando una copia de esta ordenanza, en ambos, español e inglés. El aviso se fijará en tres lugares públicos y en el kiosco de avisos del Edificio Municipal (City Hall), a no más tardar del 21vo día antes del día de la elección. La copia de esta ordenanza fijada en el Edificio Municipal (City Hall) llevará una cubierta y en la parte superior llevará las palabras "UNA ELECCIÓN ESPECIAL MUNICIPAL, 5 DE NOVIEMBRE, 2013." El aviso de esta elección será publicado en fecha que no sea anterior del 30vo día antes de la fecha de la elección en un periódico de circulación general en el mismo día en dos semanas sucesivas, y la primera publicación no deberá ser antes del día 14 anterior a la fecha de la elección.

PARTE 7. De acuerdo con el Capítulo 271 del Código Electoral de Texas la elección municipal del 5 de noviembre, 2013 se puede efectuar junto con varias subdivisiones políticas que comparten territorio con la Ciudad de Austin, y que estén efectuando elecciones en ese día. La Secretaria de la Ciudad podrá tramitar y firmar convenios electorales conjuntos con otras subdivisiones políticas para este propósito, y las condiciones según sean indicadas en los convenios por lo presente se adoptan.

PARTE 8. El Consejo determina que la necesidad de empezar inmediatamente las preparaciones requeridas para esta elección constituye una emergencia. Por dicha emergencia, esta ordenanza tiene vigor inmediatamente al aprobarse para la conservación inmediata del orden público, la salud y seguridad.

Proposition Ordinance

ORDINANCE NO.

AN ORDINANCE ESTABLISHING BOND PROPOSITION LANGUAGE FOR THE NOVEMBER 5, 2013, SPECIAL BOND ELECTION; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The Council establishes that the following bond proposition language be presented to the voters at a special bond election on November 5, 2013:

PROPOSITION

Shall the City Council of the City of Austin, Texas be authorized to issue general obligation bonds and notes of the City for the public purposes of constructing, renovating, improving, and equipping affordable housing facilities and related infrastructure for low and moderate income persons and families; acquiring land and interests in land and property necessary to do so; funding affordable housing programs as may be permitted by law to provide for those purposes; and all matters necessary or incidental thereto; with the bonds and notes to be issued in one or more series or issues, in the aggregate principal amount of \$_____, to mature serially or otherwise and bear interest at a rate or rates not to exceed the respective limits prescribed by law at the time of issuance, and to be sold at the price or prices as the City Council determines and shall there be levied and pledged, assessed, and collected annually ad valorem taxes on all taxable property in the City in an amount sufficient to pay the annual interest on the bonds and notes and to provide a sinking fund to pay the bonds and notes at maturity?

PART 2. The Proposition will appear on the official ballot in substantially the following form:

PROPOSITION

The issuance of \$_____ affordable housing bonds and notes for constructing, renovating, improving, and equipping affordable housing for low and moderate income persons and families; acquiring land and interests in land and property necessary to do so; and funding affordable housing

programs as may be permitted by law; and the levy of a tax sufficient to pay for the bonds and notes.

PART 3. The Council finds that the need to immediately begin required preparations for this election constitutes an emergency. Because of this emergency, this ordinance takes effect immediately on its passage for the immediate preservation of the public peace, health, and safety.

ORDENANZA PARA ESTATUIR EL LENGUAJE DE LA PROPOSICIÓN DE BONOS PARA LA ELECCIÓN ESPECIAL DE BONOS DEL 5 DE NOVIEMBRE, 2013; Y PARA DECLARAR UNA EMERGENCIA.

POR ORDEN DEL CONSEJO DE LA CIUDAD DE AUSTIN:

PARTE 1. El Consejo estatuye que el siguiente lenguaje de la proposición de bonos sea presentado a los votantes en la elección especial de bonos el 5 de noviembre, 2013.

PROPOSICIÓN

¿Se debería autorizar al Consejo de la Ciudad de Austin, Texas para que emita bonos de obligación general y pagarés de la Ciudad para propósitos públicos de construir, renovar, mejorar, y equipar facilidades de viviendas costeables y de infraestructura para personas y familias de ingresos bajos y moderados; para adquirir terreno y participación en terreno y propiedad que sea necesario para lo mismo; para el financiamiento de programas de viviendas costeables de acuerdo con lo permitido por la ley para posibilitar estos propósitos; y para todo asunto necesario o incidental a lo mismo; que los bonos y pagarés se emitirán en una o más serie o emisiones, en una cantidad principal total de \$_____ que se venzan en serie o de otra manera, y que el rédito o réditos del interés sea una cantidad o cantidades que no excedan los límites respectivos establecidos por ley cuando se emitan, y que se vendan al precio o precios, según lo determine el Consejo de la Ciudad; y se hará imposición, prenda, avalúo y recaudación anual de impuestos ad valoren en toda propiedad imponible en la Ciudad en cantidades suficientes para pagar el interés anual de dichos bonos y pagarés y para proporcionar un fondo de amortización para pagar dichos bonos y pagarés cuando se venzan?
