## Subject

Authorize award and execution of a 24-month requirements supply contract with HD SUPPLY WATERWORKS, LTD, for various types and sizes of PVC wastewater line fittings for the Austin Water Utility in an amount not to exceed \$294,044 with three 12-month extension options in an amount not to exceed \$147,022 per extension, for a total contract amount not to exceed \$735,110.

## Amount and Source of Funding

Funding in the amount of \$24,504 is available in the Fiscal Year 2012-2013 Operating Budget of the Austin Water Utility. Funding for the twenty-two months of the original contract period and extension options is contingent upon available funding in future budgets.

The fittings will be used by the pipeline maintenance crews, TV inspection crews, valve and hydrant crews as well as, the treatment plants for the installation and repair of PVC wastewater lines.
